

INTRODUCTION

THOZHAMAI – means Solidarity in Tamil was incepted on 23rd November 2006 as a trust under the *Indian Trust Act of 1882*. A vision came true on this day when the legend of Theater Artist and Social Activist (late) Com. Suresh Dharma's dream run came into existence. It was all the hard work and efforts made in the context of Rights Based Approach and Practices in the past one decade and the need for such a resource centre especially in the state capital of Tamil Nadu, at Chennai, has got consolidated and emerged as "Solidarity for Rights" which in turn promotes Rights Based Culture at different levels of work. Thozhamai is now the resource centre for Human Rights Work and Human Rights is especially the rights of the children, Youth and Women from the socially deprived communities.

Thozhamai since inception is working for promotion of a Rights Based Culture which will be an evolution of the Rights Based Approaches and Practices in all the institutional mechanisms both at the community level and institutional level. All the programs of Thozhamai are designed in such a manner to cater to the integrated needs of Rights Based with the emphasis to make a shift from welfare to Rights. It is serving as a resource centre at the state level to cater to the need to work on rights-based approach. Advocacy for policy change is the core of all the initiatives in Thozhamai.

VISION


A society in which the most vulnerable sections enjoy equality, social justice, freedom, fraternity, and democracy with dignity.

Semmencherry Report

CORE COMPONENTS OF COMMUNITY INTERVENTION

Empowerment: Working with rights holders to promote awareness of rights, consciousness building, and mobilization and addressing immediate needs.

Campaigning: Targeted at duty bearers this includes advocacy and mobilization for changes in policy and practice. Increased emphasis on advocacy and the establishment of strong links between local, district and national-level advocacy work.

Solidarity: Working through media, networks, coalitions, and alliances to strengthen the voice and power of the marginalized.

Eye Camp: -





Eye camp was conducted by Dr.Shilpa, Dr.Alhana Begam and other staff members of MN Eye Hospital along with Thozhamai Organisation especially for women on Women's Day. This program was conducted mainly for women who are working from the Semmencherry community. So nearly 86 women have participated in this program. Some women in the community had eye problems so they were benefited and 7 women had their eye operation and nearly 10 women were given eyeglasses. From this program they have brought health as an important concept.

Outcome:

Nearly 17 women benefited from the eye camp and this made all women in the community get to know about their vision. Through this program all the women in the community were benefited.

NCPC - Neighborhood Child Protection Committee

This Neighbourhood Child Protection Committee was formed to protect and prevent children before the abuse or accident is made in Semmencherry. There are many committees and government officials who work after the abuse so to prevent the abuse they have started this committee. With the help of Thozhamai organisation they have started this committee along with local Body Leaders, DCPU, Childline, other NGOs and Unions attend the meetings held by this committee. This committee comes once in every month and spreads awareness on the protection and prevention from abuse. This helps the children to have better understanding and knowledge of the abuse. They have a thought of creating this committee in each avenue and this committee will become the source of head for the other committee.

Outcome:

This committee helps the children to get aware of the abuse and they are benefited.

International Girl Children Day





On 11th of October 2020 girl children around 150 participated in the program which was held by Thozhamai Organisation in the Semmencherry Community. The drama was done by the staff, students and Volunteers of the Thozhamai Organisation. The theme was "My Voice, Our Equal future" and spread awareness to the girl children in the community. All the girl children who received awareness benefited. They also spoke about childhelpline number. This program mainly focused on girl children protection, discrimination.

Outcome

150 girl children who have participated have benefited from this program. This brought knowledge about protection, discrimination.

Awareness on Child Protection







This Program was initiated by the District Child Production Unit along with the Thozhamai Organisation in the Semmencherry Community by all the children in the community. They gave awareness on child protection, child helpline number. Along with the DCPU the children in the community pasted slongs in the Auto's and other common places and they spread awareness in the community. They interact with the people in the community by stating that they must send their children to school and protect their children from abuse. They had an Auto campaign and started saying slogans to the public.

Outcome:

The general public and Semmenchery community people got awareness on the importance of Child Education and Protection. And the campaign made attention to the community and the general public.

Menstrual hygiene day





This program was started or brought on a case which happened during the COVID Pandemic. During Pandemic the community people lost their jobs and girl children in the community were not able to buy sanitary napkins. So they were forced to use Cloth and that was infected and affected their Vagina and they suffered while passing Urine. So to eradicate this program the Thozhamai Organization conducted a program and gave training for three months on how to use Napkins and also about Hygiene and sanitation.

Outcome

This program has brought knowledge on how to safely use napkins and proper Sanitation and Hygiene.

COVID Relief









During Pandemic all the people in the Semmencherry community was affected and they lost their jobs so that turned to lose their daily wages which affected their daily livelihood and during that time period Dr.Samarnath was an individual sponsor who distributed essential kits to 150 families worth Rs. 750 each to Leprosy people and Irular Community in the semmencherry community. This helped the people of the Semmencherry community during the pandemic period which was really helpful for them.

Outcome

From his contribution the Irular Community and Leprosy people was helped during the pandemic.

Community Kitchen





This community Kitchen was formed mainly to cook foods for the community people. This was done during flood time as relief materials were not able to be distributed to people because the water was over flowed all over the street. So the groceries were given by the Thozhamai organisation along with TNUHDP to the community leader then they have cooked and distributed the night supper and water to people around 3000 .After that the thozhamai organisation volunteers were also combined and cooked and provided night meal to the people.

Outcome

The people in the community felt grateful for providing good food and water after a long time.

Distribution of Food and Groceries for Marginalized Families





Because of covid children was not provided proper nutritious food and many of the children become very anemic and in order to increase the healthy life style of the children of India foundation along with thozhamai organization they have provided the groceries and food to the people of following categories as follows

- 1.Diasabled
- 2.Single women
- 3.Elderly
- 4. Sanitary workers

Outcome

Through these distribution of these groceries and food to these marginalised people who is really in need of help, was highly beneficial to them

Food and hygiene kit distribution to flood affected people





Because of the flood the people living in the ground floor were heavily affected because the flood washed away the groceries and all other things in the home. In order to support them the Eastman Exports along with the Thozhamai organization has provided the relief materials like food and hygiene kit. The materials were distributed by the volunteers of Thozhamai organization to the people around 400 who is really affected by the flood and the marginalized people.

Outcome

The distribution of these hygiene kit ,food and groceries were the timely help for the people in the community

Distribution of groceries to covid affected people





During the pandemic many of the people livelihood was affected in both semencherry and perumbakkam in order to support them habitat India Ling with thozhamai organization joined and distributed 2 months of monthly groceries to 600 family

were really affected by the pandemic. This help was rendered immediately after the covid started to spread. The following are the categories of people who got the groceries.

- 1. Disabled
- 2. Transgender
- 3. Sanitary workers
- 4. Elderly

Outcome

The distribution of groceries to the affected people immediately after the covid was a timely help to them and they were very grateful for them.

SEMMENCHERRY - CHILDREN OF INDIA FOUNDATION

COVID-19 VACCINATION IMPROVEMENT PROGRAMME

BACKGROUND

Semmencherry is located near OMR, Sholliganallur, 200th ward Chennai. Semmencherry is a post "Tsunami relocation site" which was created to house 26,800 of Chennai's urban deprived community from 23 different areas and backgrounds. Semmencherry consists of 6764 families living in a house size 158 square feet. It is an urban area relocated by Tamilnadu Urban Habitat Development Board (TNUHDB) formerly known as Tamilnadu slum Clearance Board (TNSCB)

The relocation process was extremely traumatic and unethical, with houses being bulldozed without notice and people being transported in garbage trucks to the relocation sites, which were far from their personal and livelihood resources. Furthermore, the standard of living in Semmencherry is very poor, with a lack of access to basic facilities such as water, transportation, health care and schools. People were allotted small, tiny houses which do not provide privacy or security for women and there were no streetlights. People from very diverse cultures and backgrounds were placed together without any proper social integration process. Due to the lack of basic living resources and high unemployment this has caused much conflict, hostility, violence, crime amongst members of the community and some have even experienced stigmatization that further limits opportunities for employment. Displaced and homeless persons are supposed to receive priority attention, including allocation of housing and adequate rehabilitation. India should promulgate a 'right to housing' law, upholding housing as a human right and guaranteeing tenure security, as well as a 'right to homestead' law to allocate land for housing and subsistence livelihoods to landless and homeless people. But most evicted people do not have access to justice and their right to effective remedy has not been fulfilled. Where they have been able to approach courts and receive favorable orders, relief has mostly been in the form of stay orders related to further demolition/eviction. Seldom have courts ordered restitution and restoration of human rights of aggrieved persons to resettlement, return, adequate housing, and other rights that are violated as a result of forced evictions.

Evicted communities face challenges with regard to housing and basic services. The sites lack security for residents, especially women and children. In the absence of piped drinking water supply in the tenements, residents are forced to fill drinking water from tankers and carry it in buckets to their homes. This is especially difficult for women, persons with disabilities, and older persons, who have been allotted tenements on upper floors. Another critical issue that has affected habitability of

the site and health of the residents is that of seepage in the buildings resulting from poor quality building materials, inadequate construction, and bad plumbing design. Hence residents are afraid for their lives because of the structural instability of the buildings. These fears heighten if there are earthquake tremors. Relocation has adversely affected livelihoods of affected persons, including women and disrupted children's education

SPECIFIC ISSUES

In Tamil Nadu,most of families evicted were relocated by the State Government and provided alternative tenements constructed by the Tamil Nadu Slum Clearance Board. The resettlement sites, however, are located on the outskirts of cities, at about 30-40 kilometres from residents' original sites of habitation.

Families resettled in the remote site continue to face multiple challenges. These include the poor quality of housing and inadequate civic and social infrastructure facilities, such as the lack of sufficient water, street lights, working lifts, schools, day-care centres, healthcare facilities, transportation and access to burial and cremation grounds. Relocated families also have raised concerns about the lack of security at the site, which has disproportionately affected women, children, and older persons of the community.

Relocation has severely affected their social and economic mobility and is also a violation of their human rights to livelihood/work, security, equality, and freedom of movement. Thousands of school-going children have been affected by the absence of adequate schools and educational infrastructure. In the absence of toilets in the primary schools, children are forced to defecate in the open, which disproportionately impacts girls. The sites haveno or very limited Public Distribution System/ration shops for subsidized food and anganwadis/creches under the Integrated Child Development Services scheme. This has greatly affected the human rights to education and food of affected families, especially of pregnant and lactating women and children. Insufficient water supply also disproportionately affects women and children. All relocated families have experienced a loss of their livelihoods because of the remote location of the site and the lack of employment options in the vicinity. Furthermore, some residents report that the stigma attached to the resettlement sites also impedes their ability to find employment.

Preliminary findings reveal extensive losses suffered by families, including a reduction in their average monthly income. Children in the community, especially girls, dropped out of school after the eviction. In the post-eviction period, an increase in the number of complaints of violence against women and girls was reported. Families also incurred an increased average monthly expenditure on healthcare and food.

In most of the evictions and demolition of homes, there has been little or no compliance with human rights safeguards and international guidelines, including the UN Basic Principles and Guidelines on Development-based Evictions and Displacement. The processes followed before, during, and after evictions have resulted in the violation of multiple human rights of affected persons. Each member loses a 'bundle' of rights-the right to livelihood, to shelter and security, to health, to education, to information, participation, freedom of movement, access to civic amenities like food, water, sanitation and public transport and above all, the right to live with dignity. Those who are already suffering from chronic or acute health issues often face increased morbidity after evictions, as a result of living out in the open or in makeshift conditions, and thus succumb to their illnesses much sooner.

The financial losses incurred by already economically marginalized communities as a result of forced evictions, including the increased cost of rebuilding homes and the loss of livelihoods and days of work, have contributed to a sustained deterioration in their standard of living with long-term health impacts. Also, the psychological impacts of forced evictions, especially on children, are seldom acknowledged or addressed.

A direct result of forced evictions on marginalized communities is the increased rate of malnourishment, malnutrition, and hunger. In the aftermath of a forced eviction, families are not able to cook food or spend money on food. This is also because they lose food supplies and cooking implements during the brutal demolition drives. The surge in expenditure related to rebuilding homes or relocating, and the inevitable loss of income resulting from loss of livelihoods also contribute to a much lower expenditure on food and healthcare, which directly contributes to increased morbidity and vulnerability of evicted persons, especially children, older persons, persons with chronic and serious illnesses, and pregnant and lactating women. Inadequate living conditions resulting from loss of housing directly contribute to a deterioration of the health of affected persons.

As affirmed by the United Nations, the act of forced eviction is a gross violation of the human right to adequate housing. When the state demolishes houses, people lose not just the roof over their heads but their security, safety, and substantial investment in that housing, which is often built over many years with hard-earned savings and personal labour. Since resettlement is seldom provided to affected families, they are either rendered homeless or forced to live in very inadequate housing. This affects the realization of multiple human rights of affected persons and results in an overall deterioration in their standard of living. The loss of housing for children has serious long-term impacts and greatly impedes their development as well as their ability to study, play and grow in a safe and secure environment.

Forced evictions also violate the human right to security of the person and home, and increase vulnerability of evicted/ displaced persons, in particular of women and children, to a range of violations, including sexual violence and abuse and an increased threat of trafficking. In some instances, early marriage of adolescent girls has been reported in the aftermath of an eviction, as parents, worried for their daughters' safety, prefer to marry them off rather than have them are homeless or in insecure and remote resettlement sites.

Thus, **Thozhamai networking with Children of India Foundation**, is taking joint effort with the objective of initiating behaviour change communications for mitigating people's apprehensions and hesitations for increased covid vaccination for reaching **12000 doses from September 2021** –

- Door to door visit for vaccination drive by health workers which helps disabled, senior citizens and pregnant women in taking Associated with Directorate of Public health in getting sufficient vaccination dg vaccination

WHAT WENT WELL AND THE FACTORS BEHIND THEM

- Camps are setup and advocated with Government of Tamil Nadu and insisted for setting up weekly Mega vaccination campaign and two day from mid of November
- Handing with Urban health centre and improving equipment's in hospital i.e Pulse oximeter, InfraRed Thermometer, Face shield, BP machine, Sanitizer, vaccine container, Gloves
- Megaphone and remote audio system which helped them as communication for door to door vaccination
- Logistics arrangement for each campaign which helps them for transiting the vaccination materials
- Display of banners in health centre premises
- Support role and add-on to the vaccination improvement programme
- N95 masks to each beneficiaries who take up vaccination
- Refreshment to each beneficiaries who take up vaccination
- Easy access to vaccination in taking from the houses
- Travel facility for disabled, senior citizen and pregnant women
- Knowledge and community people are more trusted through our audio jingles and awareness IEC materials

- Door to Door visit through mobile van to create awareness about vaccination to people. We also informed people about the merits through IEC's as well as sharing trusted information for getting vaccinated
- Fake information / Rumours was communicated around the community, however we
 had shared the trusted information
- Many people avoid taking vaccination on mega vaccination day as they could not take consume non- veg menu and vaccination day has changed to alternative day
- During Floods, community people were very much hesitated to take vaccine as they are already suffering mild illness and cough. However we convinced and made to take up vaccination

INSTITUTIONAL LEARNING FOR THE ORGANISATION FROM THE PROJECT

- No proper plan / place for vaccination and we mitigated by providing our children activity centre for vaccination
- Vaccination campaign happens in around 8 places in and around the community, there
 was challenge in collecting and consolidating the data and we mitigated by setting up
 campaigns and volunteers supported for entering the data in the system
- During Flood the hospital was flooded with water and vaccination place was switched over where water is not stagnant at Kumaran Nagar

RECOMMENDATIONS FOR THE FUTURE INTERVENTIONS

- Urban Health centre has limited facilities, however we provided the health materials,
 but there was only one standalone computer and slow internet connectivity. We have
 supported by entering from our office computer as well as through smart phone
- Networking with Greater chennai corporation workers workers to inform and promote about Corona through megaphones even on working days and holidays and told them to get vaccinated
- The vaccination happen every day from 6am to 8pm, we have arrange and informed to volunteers to work according shift basis

CONCLUSION

- Waist coat, T-shirt, Face shield, caps and safety materials like masks, gloves and sanitizers for each staff and volunteers
- Lobby and associating with Urban Health Centre for vaccination improvement programme
- Vaccination for disabled, senior citizens and pregnant women which made to feel great and proud in our community

shOUT for Freedom is an alliance of like-minded apolitical individuals and organizations who strive to assist combatting of the bonded labor. Our vision is to see all citizens' work with freedom and dignity in compliancy with the legal standards. Everyone in the alliance have joined together with the objective to create an awareness about bonded labor (BL) and human trafficking (HT) issues to the public and by all possible means supporting the state to combat the issue of Bonded Labor and human trafficking.

Whereas, during the prevailing COVID pandemic, many migrant workers are stuck at borders, including state, district and at national border areas. The migrant workers are struggling without food, shelter, and transportation back to their native State in India.

Whereas, in order to provide relief materials to the vulnerable migrant laborers in Tamil Nadu and to release a report on challenges faced by migrant laborers in TN during COVID lock down through shOUT for Freedom alliance. The Second Party has requested the first party for support with a financial assistance for a period of 3 months and the first party has considered that request and has decided to support the second party with a financial support





UNICEF conducted webinar series partnership with Thozhamai & Stella Maris college. Topic was Impact of Migration & Covid-19 and Children. The resource person was Dr.Baishall (Associate fellow - Socio-economic & environmental studies, Ernakullam), Dr.Vinoj Abraham (Proffesor-Centre for devlopement studies, Thiruvanthapuram) & Dr. Praveena (Proffesor-center for developement studies, Thiruvanthapuram). In this trining we came to know how much the migrant children would get spoiled and how they could continue their studies and all. Then we collected information the no. of children was migrated from 2001 to 2011 to city to city.

IMPACT: The training made us to know how the migrant children were affected and still affecting. We learned more for migrant children's issues and crosscut issues of caste, religion, Gender, education & livelihood etc.

Other Activities:

- 1. Activity on world Anti child Labour Day: The activity was done to express awareness for world anti child labour Day. In advance of world Anti child labour day and to give awareness for it the goal staff and CSC's were prepared slogans and Drawing in the name of "World Anti child labour", the child labour should get Education not tools to work. The slogan was posted in the face book to say about that "SAY NO TO CHILD LABOUR".
- 2. Activity on world tobacco day: Staffs & csc's were participated in the different activity like drawing, poster designing & slogan contest and 2 staffs & 1 csc's got online participant certificate.

Engagement of Media, young people and community interventions for prevention of Covid-19

INTRODUCTION

COVID-19, "once-in-a-century pandemic", has thrown into stark relief the intersectional invisible sections of Indian society. The urban poor comprising of migrant community, urban homeless, residents of informal settings, residents of resettlement colonies, and large number of unorganized workers are the worst affected sections of the society. In most cases, our urban centres are our economic nodes as well. A key feature of the urban economy in India, consistent with most developing economies, is the role played by informal workers and the unorganized sector. To put things in perspective, about 90% of India's total workforce of about 500 million workers is engaged in the informal sector.'

Factories, industrial units, hotels, restaurants and many other establishments, irrespective of their scale of operations, depend on such workers. Large proportion of the urban poor living in such settlements form a majority of those who do menial jobs in cities, including the frontline sanitary works of the local bodies. Many of them are Dalits, which is a secondary intersectional burden. Most of this class is made of people who have shifted to urban areas looking for better livelihood opportunities. India saw about 450 million migrants within the country, out of which 78 million people moved to urban areas from rural parts.





The corona virus outbreak exposed their vulnerabilities in ways that probably few other incidents have in the recent past. The lockdown has intersected with their pre-existing disadvantages, bringing to the fore inequalities; discrimination and anxieties. Some of the major challenges

include lack of job security, limited or no access to banking and insurance channels, a generally under-developed public health system. The guidelines issued by Government of India for the 5th lockdown on May 30, 2020 also suggest stringent lock down in the containment zones particularly in Chennai. This will further make the already poor families more vulnerable and go hungry in the coming weeks.

There are a lot of myths, misconception and misinformation about corona virus which are being found in the social media and digital online platforms. This information is misleading people and breeding stigma and discrimination in the society. So it is of utmost importance to take preventive steps to ensure that people particularly youth get correct information. The facts about COVID will be the best medicine to stop the transmission. UNICEF and Thozhamai jointly implemented the awareness program in Community level, journalists and youth advocates also to create various types IEC (Information Education Communication) materials.

AIM OF THE PROJECT

- 1. To create an enabling environment in resettlement colonies of Chennai
- 2. To create awareness among Journalists and youth about Covid-19 and its prevention measures.
- 3. To develop and facilitate creation of relevant IEC materials related to Covid-19.

OBJECTIVES OF THE PROJECT

- ➤ To give orientation for Adolescents and young people through network meeting regarding issues faced by them during Covid-19 pandemic
- > Sensitization of 3000 Women SHG members on complications faced during Covid-19
- To enhance the parenting skills particularly during the Covid-19 pandemic situation
- ➤ To change the behaviour of community people through religious leaders that people those who are not the following the guidelines of Covid-19 preventive measures as they feel they were safe with the strong religious beliefs.
- To conduct orientation for journalists through virtually in order to reach large number of common people with Covid-19 awareness key messages.
- To sensitize the young people those who are associated with National services scheme (NSS) of colleges and universities through virtual programs on Covid-19 awareness. These

sensitised young people will create awareness and pass the information through social media.

- ➤ To engage the common people through organizing webinars by celebrity/Anchors of TV/Radio during Covid-19 crisis.
- ➤ To create/facilitate/coordinate IEC material of Covid-19.

Community Interventions for prevention of Covid-19

Despite the best efforts by the government, given the present uncertain circumstances, it is inevitable that in a diverse country like India, social vulnerabilities and inequalities are bound to erupt alongside the pandemic. It is estimated that in India, 29.4% of the urban people live in informal settlements (formerly called slums) and their condition is just a shade better than the homeless for the fact that they have a roof over their head. Thozhamai has been working in Semmenchery, a resettlement colony in Chennai, where about 6764 families and 26,000 people live. All these families are daily wage labourers and live in abject poverty. Semmenchery is one of the largest gated communities with only one entry point with 10 avenues and 100 streets.













In a resettlement colony like Semmenchery, however, they suffer from all the vulnerabilities of the homeless and slum people, including severe health issues. Most of them live in very small structures that house a large number of family members and the currently prescribed social distancing norms are impossible. As could be seen during this lockdown, many from the informal settlements continue to do conservancy work such as sweeping and segregating and disposal of waste. The high rate of risk that these workers will get infected is ignored. They will choose financial survival in their compelling trade-off with physical health. Again, in the eyes of agencies, when it comes to the homeless and informal settlers, only the general categories among them count and when it comes to "conservancy work", it is the overall local body workforce that will come to mind. However in practice, the women, Dalits and the sick among them are forced into intersectional invisibility in spite of their very high physical visibility on the roads and streets.

This becomes more complex when COVID-19 intersects with their pre-existing systemic and multidimensional vulnerabilities. Those informal settlements and resettlement colonies might have already had chronically ill patients and many people who are prone to such vulnerabilities. When COVID-19 intersects alongside such risks, then their potential for resilience is greatly diminished. In these circumstances, the sudden restrictions imposed on them without addressing their immediate requirements may not be sustainable and might only cause additional hardships. As on May 29, 2020, there are 42 Covid-19 positive cases in Semmenchery colony and if the root causes for such a spread is not addressed immediately, covid-19 is bound to spread like wildfire.



In Semmenchery community there are 6764 families in 10 avenues which shared by 10 volunteers respectively to done the Covid-19 awareness work in field level also 5 motivators from Thozhamai to support the volunteers. The prepared Cluster wise micro plan is as follow:



To strengthen the volunteers and motivators conducted orientation sessions on Ending Stigma and Discrimination about Covid-19 and taught coughing procedures to prevent people from Covid-19, hygienic practices during the Menstrual period, Ending Child Marriage Child Protection, importance of immunization, breast feeding and key messages for pregnant women during the Covid-19 Using the above-mentioned methodology intervene the community to prevent the Covid-19 with the following activities:









Orientation of Adolescents and young people network meetings

In Semmencherry community we had adolescent group, the volunteers reached those adolescents from each avenue and following are the focused activities done in the community.

- Weekly twice created awareness on Ending Stigma and Discrimination about Covid-19
 and taught coughing procedures to prevent people from Covid-19 with the adolescent
 group. Also the volunteers distributed the IEC material on Covid-19 preventive measures
 to the respective avenues.
- Volunteers created awareness among the adolescents and young people about health and hygienic practices during the Menstrual period on weekly twice.
- During this pandemic situation the adolescent were facing lot of psycho social problems in Semmencherry. To overcome their psychosocial problem the organization planned and guided the volunteers to conduct the Life Skill Education for ten groups of adolescents from 10 avenues each group contain 10 adolescents. The following were the highlighted points discussed in the orientation session.
 - o Peer pressure on online games, no sharing selfie video calls.
 - Learn to say no for avoiding the peer pressure
 - Good leadership quality
 - o My body my rights
 - Uncomfortable situations in changing the sanitary napkin and the disposal problem faced during the lockdown situation.

- Conducted drawing competition on 08th September 2020 in order to celebrate International Literacy day. 25 adolescents were participated and appreciated them with small gifts.
- Organized awareness programme about Ending Child Marriage for adolescents to celebrating the International Girl Child Day on October 14th 2020.
- World Children's Day 20th November 2020 offers each of us an inspirational entry-point to advocate, promote and celebrate children's rights, translating into dialogues and actions that will build a better world for children. According to these words, conducted orientation on "Child Rights" and made the day memorable. 5 adolescents participated from each avenue totally 50 adolescents.
- On 15th October 2020, Global hand washing day taught rhymes on hand washing techniques with actions. The adolescents were enjoyed it. From each avenue 5, so totally 50 adolescents were participated.

Through the above-mentioned activities covered 4543 adolescents with support of 10 volunteers and 5 motivators.









1.2 Sensitization of SHG members:

The volunteers sensitized the SHG members through following awareness programme:

- ➤ Conducted orientation program for 40 SHG members on importance of immunization, breast feeding and key messages for pregnant women during the Covid-19 Highlighted the 21 interventions in the first 1000 days from conception to second year of birth and also to highlighting the **World breastfeeding Week** on August 1st week.
- ➤ To ensure the healthy measures during this pandemic situation volunteers organized orientation programme for the SHG members to segregate the Degradable and biodegradable waste for trash on weekly twice
- ➤ Organized awareness programme on Ending Stigma and Discrimination about Covid-19 and taught coughing procedures to prevent people from Covid-19 for domestic workers of SHG members about the Covid-19 safety measures and Distributed the Covid-19 pamphlets
- The volunteers organized awareness programme about the Importance of Child Protection and the necessity to involve the SHG members on child protection. The above mentioned topic was addressed by Mr. Devaneyan, Director of Thozhamai. 50 SHG members participated in the awareness programme 10 members from each avenue.





Parent's Engagement:

- ➤ Mobilized the parents for enhancing their Parenting Skills during Covid-19 Situation and conducted orientation session for the mobilized parents on "Parenting Skills"
- Awareness materials on prevention and safety measures of spread of Covid-19 during Nivar cyclone were disseminated through social media among the parents for enhancing their knowledge during Covid-19 Situation.



Community people engagement through religious leaders:

- ➤ Distributed the pamphlets along with communication related to Covid-19 from public audio system to the community through the religious leaders of Temple and the Mosque.
- ➤ To highlight the importance of hand wash as well as Global Hand Washing Day on 15 October 2020. Volunteers are oriented on the importance and necessary of handwash. They took the message and started spreading the message on the community people and made demonstration methods in their respective avenues for highlighting the theme 2020 "Hand Hygiene for All"
- Awareness materials on prevention and safety measures of spread of Covid-19 during Nivar cyclone were disseminated through social media among the various groups throughout the community. The volunteers are also supported for food distribution through community kitchen and ensured to follow safe distance for prevention of spread of Covid-19.




Sensitization of young people of NSS

Webinar about Bonding with Children during Covid-19 pandemic association with GT group of institution on 30.06.2020

GT group of institutions and UNICEF jointly organized the Parenting webinar on 'Bonding with children during pandemic' on 30th June 2020. Above 500 parents and their children were participated in the webinar session.

Mr.Sundar Jagalan, principal of GT group of institution opened up the webinar session, then Ms.Sujiaya, Faculty of GT group institution welcomed the gatherings. Mr.Sugata Roy introduced the two eminent speakers Ms.Nalinaram, working for parenting magazines in Harini Media Ltd. and Ms.Arundhati swami, pioneer in family and school counselor in Chennai.

Ms.Nalinaram explained that, one hand parents were very anxsious about their own health and families' health, in other hand worried about the stability of the work, finance and the child education. This anxiety tends to reflect to the child event they don't talk with the children because the children pickup the parent's sense easily. Besides the child's mind being anxious about corona virus, so many changes they think about wearing mask, social distancing, missing outing with friends, outdoor games. These are the trying times for both the parents and children. Though we are facing the uncertainty but spending more time with the family together. So this pandemic situation made connectivity between parents and children.



Arundhati swami delivered about the importance of connection between the parent and the child. She shared the points about this pandemic though scary and frightening really thrown up great opportunity to the family to meet together whether liked it or not. Let examined this pandemic situation, the children hangouts the school, no friends, no relatives, so complete stand still because of one little virus. But now the family or parents are the centre for children. The primary reason there need to be is available because they are seeking support most of the time. So spend time with the children like playing, cooking, gardening, house cleaning. Also she said that emotional connection between the child and the parent was very important, build trust with the child and the child felt secured.

Ms.Nalinaram said that in this scenario with understanding the connection with the child there are 4 key situations



- 1. Connecting by engaging your child in every day moments
- 2. Connecting the child when going into emotional situation
- 3. Connecting the child with the conflict situation
- 4. Connecting the child when you lose the control

With this 4 key situation the both speakers given tips for the parents to connect the children>

1. Connecting by engaging your child in every day moments

In this situation was explained by the speaker Nalinaram and she point out that, from the morning spend time with the child like wake up the children from bed and say good morning, play games, eating together, sharing experiences, ask the children to help cleaning, in cooking ask them to choose the dish..

2. Connecting the child when going into emotional situation:

This connecting situation was briefed by the Speaker ArundathiSwami and she said that emotions are expressed as happy or sad for attentions seeking the child express the emotions. So the parent should think about expression and acknowledge the child's emotions, don't turn away from the emotion of the child.

3. Connecting the child with the conflict situation

Ms.Nalinaram said that depending on the mood of the parent should react with the children. First realized the upset conditions then talk with the child. Stay calm first then react. Please empathy with your child; if you react the conflict situation with your child, they won't respond you.

4. Connecting the child when you lose the control


When the parent loses their control, they should go back to their child and repair the broken relations. Apart from the emotions it hurt the child so ask to apologize with the child then the child knew how to apologize.

Social Stigma and Discrimination

Corona spreading cause fear and anxiety and it leads to prejudices against people and communities. This situation creates the social isolation and stigma. It's a new disease and for which there are still many unknowns and lot of confusion in preventive measures. It is understandable that there is confusion, anxiety and fear among the public, these factors are fueling the harmful stereotypes.

When talking about corona virus disease, certain words(i.e suspect case, quarantine...) and language may have a negative meaning for people and fuel stigmatizing attitudes.

Addressing Stigma:

Sufficient knowledge about how the new corona virus disease (COVID-19) is transmitted and treated, and how to prevent infection

Prioritize the collection, consolidate and disseminate of accurate country and community specific information about affected areas

Individual and group vulnerability to COVID-19, treatment options and where to access health care and information.

Use simple language and avoid clinical terms

Social media is useful for reaching a large number of people with health information at relatively low cost.

Finally the webinar was end up with the closing remarks was delivered by the staffs of the respective organizations. The session was very informative, and it makes the participants to realize and non-discriminate the infected persons with corona virus.

pandemic admits all the eventually and parenting would be more than extending care in successful morrow. She emphasized on the children takes the parent as a role model, the child is independent morrow so the parent not interfere their life but support, motivate and encourage the child to do their activities and keep the expectation at reasonable level.

The speaker divided the parenting style into three types

- 1. Authoritarian: the parents order the child to obey their words but this century it not works
- 2. Democratarian: the parents share together with the child and given chance to take decision, the parent found successful child.
- 3. Autocratic: spoils the child greater extent and permissive behavior

Dr.Kalpana given ideas to the parent to know about the child's advantage and disadvantage and she insisted that the parent should really found out what their child wants to become, don't be judgmental and comparing every child has unique way to represent their identity. She also suggested the parent to some important values to teach the child like legal and financial responsibilities and it makes the child successful morrow, teach the well being of the child, teach them healthy and safety social life, teach emotional development and develop the intellectual growth, teach them to helping the poor, helping the blind to cross the road, given reward for positive thing and punished the child if doesn't obey the rule, teach them to maintain the safety environment. She advised that always the parents should behind the child with their own believes so trust the child then only the child trust themselves. Finally she touched the point about the Covid-19 and asked them to teach them safe and healthy life in pandemic situation. She ordered all the parents to divert the children from the cell phones.

The session was ended with the vote of thanks delivered by Ms.Kavitha, Mathematics teacher of MVM.

Webinar Series on impact of Covid-19 on Migration from 16.06.2020 to 06.08.2020

Background of the Migration Webinar Series

India is a vast country, and every year a substantial number of people migrate to larger cities of different states for seeking employment opportunities to earn bread and butter for their family.

Reverse migration refers to movement of people from place of employment to their native places. With the world coming to a standstill due to lockdown as a measure to combat COVID-19, limited employment opportunities, impending fear of unknown future and financial crisis, thousands of underprivileged people and labourers started to march back to their native places and home states. According to a report by World Bank, more than 40 million internal migrants have been affected due to COVID-19 and around 50,000–60,000 individuals migrated from urban to rural areas of origin in a period of few days. This internal migration of reverse nature is reported to be two and a half times that of an international relocation.



In the absence of transport facilities, during lockdown, the panic-stricken laborer's and their families including infants, pregnant women and the elderly walked thousands of kilometers barefoot without food and money to reach their native places. Many of these migrants were left stranded mid-way, facing starvation and misery, and some even died before they could reach their destination. In this regard UNICEF had played a major role to voice out for the migration to take the action creates awareness among the youth advocates and the Civil Society Organization about Migration and their children facing problems.

Objective of the webinar series










Covid-19 Talks 2: Managing Mental Health & Psycho-social consideration during Covid-19 on 16 September 2020








Covid-19 Talks 4: Risk Communication and Community Engagement during Emergencies on 30 September 2020


