INTRODUCTION

THOZHAMAI – means Solidarity in Tamil was incepted on 23rd November 2006 as a trust under the *Indian Trust Act of 1882*. A vision came true on this day when the legend of Theater Artist and Social Activist (late) Com. Suresh Dharma's dream run came into existence. It was all the hard work and efforts made in the context of Rights Based Approach and Practices in the past one decade and the need for such a resource centre especially in the state capital of Tamil Nadu, at Chennai, has got consolidated and emerged as "Solidarity for Rights" which in turn promotes Rights Based Culture at different levels of work. Thozhamai is now the resource centre for Human Rights Work and Human Rights is especially the rights of the children, Youth and Women from the socially deprived communities.

Thozhamai since inception is working for promotion of a Rights Based Culture which will be an evolution of the Rights Based Approaches and Practices in all the institutional mechanisms both at the community level and institutional level. All the programs of Thozhamai are designed in such a manner to cater to the integrated needs of Rights Based with the emphasis to make a shift from welfare to Rights. It is serving as a resource centre at the state level to cater to the need to work on rights based approach. Advocacy for policy change is the core of all the initiatives in Thozhamai.

VISION


A society in which the most vulnerable sections enjoy equality, social justice, freedom, fraternity and democracy with dignity

MAKING YOUR OWN CHOICES YOUNG URBAN WOMEN

WOMEN RIGHTS

ADOLESCENT GIRLS GROUP MEETING

The main objective of the Adolescent group formation (Girls) is to give training on their basic rights and to address their rights among community. The Adolescent group has 15 members .We had a meeting regarding the problems faced by girls in the community. From this month the adolescent girls have been joined into the sports, through the sports we teach them life skills and major body changes for adolescent girls followed by SRHR.

WOMEN'S DAY

Based on the women's day we created stickers and pasted it in the public places. The stickers were about the women safety (181) and child safety (1098) number in it. Our adolescent girls, adolescent boys group and women group part of Thozhamai pasted in the community, public places like school gate, ration shop, parks, shop and at their doors. It created a huge impact among the public because most of them were seeking help about the women and child helpline.

SEXUAL REPRODUCTIVE HEALTH RIGHTS - ADOLESCENT GIRLS

Adolescent girls participated in Campaign on Sexual and Reproductive health Rights (SRHR) at Besant Nagar. The objective of the campaign is to address the MY BODY, MY RIGHTS and we educate about safe touch and unsafe touch. The adolescent girls mainly educated by the reproductive and health rights.



OUTCOME: Monthly training on Sexual

Reproductive health rights has been initiated for Young urban women and adolescent girls

AWARENESS ON DOMESTIC VIOLENCE

Awareness on violence against women conducted for women which are focusing mainly on Domestic Violence in Semmencherry. The resource person for the programme was Ms. PalaniAmmal from Uraimai Kural . About 25 women participated in the Awareness programme

which is conducted in Semmencherry, branch office. And learnt "MY RIGHTS, I HAVE TO DECIDE" following Thozhamai disturbed Workers Note book for domestic workers to follow their attendance. Ms. PalaniAmmal orientated about domestic violence, violence or abuse is by one person against another in a domestic setting such as marriage. It may be termed intimate partner violence when committed by a spouse or partner in an intimate relationship against the other spouse.

- "Physical abuse" includes hurt of any kind. Assault, criminal intimidation and criminal force.
- "Sexual abuse" such as conduct of a sexual nature such as forced sexual intercourse, forcing the aggrieved person to watch pornography or other obscene material. Forcibly using woman to entertain others, any other act of sexual nature, abusing, humiliating, degrading or otherwise violation of one's dignity
- "Verbal and emotional abuse" such as Accusation/aspersion on character or conduct. Insult for not brining dowry, Insult for not having a male child. etc. Forcing to not attend school, college or any other educational institution preventing one from taking up a job repeated threats to cause pain to any person in whom the woman is interested. Preventing from marrying a person of your choice.
- "Economic abuse" such as not providing money for maintaining woman or her children Not providing food, clothes, medicine. etc, Forcing woman out of the house. Preventing from accessing or using any part of the house, preventing or obstructing one from carrying on employment Non-payment of rent in case of a rented accommodation, selling or pawing stridhan or any other valuables without informing and without consent. Forcibly taking away salary, income or wages etc. Non-payment of other bills such as electricity, etc

 She also oriented about the domestic violence act 2005. The protection of Women from domestic violence Act 2005 is an Act of the parliament of India enacted to protect Women from domestic Violence.

PROTEST ON WATER ISSUES

Young urban women the members of Thozhamai protest in Semmencherry regarding the water issues. People in Semmencherry had no water for past 4 days, where women group and young urban women met the officials and complained about the water issues. And finally young urban women and women started to protest in middle of the road. Around 100 women started to protest in middle of the road and near water department which is located in Semmencherry. Finally the police officials provided water in the tank and from next day onwards the water was regular. Through our training we empowered the women and they raised their voice against government for their own needs in the community.

OUTCOME: Our training on RTI filing and petition the women are following that and women group filed petition for water issues and are regular now, the government is providing water twice in a day, morning and evening. This issue was covered by all media and published in the newspaper.

Networking with Local Governance



Community needs were created by community women and children needs. Through many training the women and children discuss the needs and problems of the community and the assessment sheet was given to the local governance. All those needs were created as a book and submitted assessment sheet

ADMISSION FOR COLLEGE STUDENTS

We got three admissions for Semmencherry girls in Government Arts and Science College Perumbakkam. Three girls from underprivileged background where their mother is housekeeping and can't afford fees and bus fees for them but those girls are interested to do their bachelor degree. So we got admission for these three girls nearby their house where their family can be comfortable. Promoting women rights and strengthen their livelihood through education and decent career after their degree.

OUTCOME: Three of the girls the marriage has been stopped and they are continuing their education

CASE STUDY

NAME: LAVANYA

AGE: 17 years

VILLAGE: SEMMENCHERRY

I am Lavanya and I am 17 years, I live in Semmencherry more 10 years with my family and we evicted from Adyar. My father is not working and he is an alcoholic and my mother working as housekeeping in a beauty parlour. And we are three daughters; I have an elder sister who is studying college and younger sister who is studying 11th standard in government school in Semmencherry. I completed 12th standard and planned to join in any college. But my mother was supporting me to join college and father did not encourage me to join in college and forced me to get married to my uncle son. My elder sister and my mother told supported me to join college and tried to convince him. Because my father is thinking that we have three daughters and I am the second daughter and they can't make me to precede my education further. My cousin family also supported me to get married to their son.

After completing 12th standard my parents initially didn't allow me to study further and gradually my mother supported me to join in college and I got into college with the help of Thozhamai and they also support my education financially by paying my college fee. I have attended much training which educated me the correct age when a girl should get married through child marriage training in Thozhamai. I told my parents about the correct age to get married and told my right to education.

Through Thozhamai I have been benefited a lot, I also participated in jewellery making course which was conducted by Thozhamai, I have benefited a lot from Thozhamai and they educated me what is my own rights and what is the correct age to get married. And I will return home by 12: 30 pm after college so it will be helpful if I get a part time job after my college and I can pay my own fee and can't depend upon my father.

JOB MELA

Thozhamai conducted JOB MELA for young urban women in Semmencherry. The main objective of the JOB MELA is to create economic security among the young urban women in Semmencherry and to break the area stigma. About 30 young urban women participated in the job Mela.

From Unlimited showroom HR came and oriented young urban women about the job vacancy. It a showroom located in OMR, around 4 young urban women have been recruited for unlimited showroom job. It is a day swift work for women in the community.

OUTCOME: We directly oriented and kept job Mela for 30 women and indirectly through women group around 10 of them have been going to the job.

WOMEN GROUP MEETING

On 13th June 2019, Thozhamai conducted women group meeting in Semmencherry field. About 32 women participated in the women group meeting. Ms. Kanchanna, Sponsorship Coordinator and Ms. Lilly both facilitated the women gathering. The main objective of the meeting is discusses about the work done in previous meeting and the status of petition filed against graveyard and vermicompost area near the households.

Ms. Lilly highlighted the objective of the right based group forming in the field and what are the uses of right based group. She also mentioned the duties and responsibilities of right based group. The major discussion was about the election manifesto was submitted to the election party DMK, and they won the election and the women are planned to meet the MP and to address about the issues to the MP. Based on the election manifesto the women going to meet the MP were discussed in the meeting.

SRHR TRAINING FOR ADOLESCENT GIRLS GROUP LEADERS

On 22nd June 2019, Thozhamai Adolescent girls participated in training on Sexual and .Reproductive health Rights (SRHR) for group leaders of Adolescent girls. Around 15 of 2 leaders from each group attended the sexual and reproductive health rights in the field office. Ms. Sumithra, Community Mobilizer facilitated the leaders in the training. The objective of the campaign is to address the MY BODY, MY RIGHTS and we educate about safe touch and unsafe touch.

Through this training the leaders are asked to take class in front of other leaders to ensure how to convey their message to their group members in a right way. Every leader had a chance to participate in the training and well trained about "MY BODY, MY RIGHTS" and none of them

have rights on their body including parents. Ms. Sumithra oriented about the child marriage and how to stop child marriage in the community, she told to contact 1098 if they faces any problem or they have to address their issue to local Non-Governmental Organisation.



CBO GROUP MEETING (WOMEN)

On 25th June 2019, Thozhamai conducted CBO group meeting for women in Semmencherry branch office. Around 20 women from each group leaders participated in the CBO group Meeting. The main objective of the CBO meeting is to train the women to make community based organization and to create awareness about the people's organization and participatory approach to fulfil our community goals. Ms. Kanchanna, Sponsorship coordinator facilitated the meeting.

She orientated about the objective of the CBO, Mission and vision about the CBO, how to form a CBO and what are the steps to be followed in CBO. All the group leaders will be conveying this to their peer group and group members presented. It was CBO planning meeting and fixing up the leaders of the CBO in Semmencherry.

LOCAL NETWORK MEETING

On 27th June 2019, Thozhamai conducted local level network meeting in Semmencherry Branch office. The main objective of the meeting is to ensure what are the gaps are missing in the community and how the local network can build a bridge between the people and networks. Many local networks like doctors, ICCW teachers, health department, other local NGO like Aware India, ICCW, Thiruvallur Sagam (Local sagam) and other groups like women, parents group participated in the meeting.

The community women explained what are the problems occurs because of the network and what are the things which is lacking in the community for that network officials answered to the community.

INTERNATIONAL YOUTH DAY

International youth day was conducted in Mohammed Sathak College of Arts and Science by Thozhamai. Around 500 youth participated in International Youth Day. The major objective of the programme is to emphasis on transforming education to ensure inclusive and equitable quality education and promote lifelong learning opportunities for all. The major focuses on the youth speak out for rights.

The chief guest was Prof. Sundaravalli, Tamilnadu Progressive writers & Artists Association who addressed the problems and struggles about youth in the society. Thozhamai in Network with

Youth for Advocates (UNICEF) have played a street theatre regarding the problems faced by women in the society.

OUTCOME: Young urban women came to know about the struggles facing in the real life and the women helpline

WOMEN CONSULTATION

Mr. Sunitha, Programme Officer, Mr. Sathyam from Action Aid, Ms. Kanchanna, Sponsorship Coordinator conducted the consultation for women. The purpose of the meeting was to address the need of the community people and to create friendly environment. Facilitate a new change in minds of women in the community.

Improvements made

Before

- There was no CCTV fixed
- Doctors in UHC during evening times were not available
- Frequency of bus were less
- Water supply was available once in 2 days
- Availability of doctors in UHC was also less.

After

- CCTV is fixed now
- Doctors are available in evenings
- Frequency of buses is increased
- Water is being supplied daily
- Now doctors from different institutions are available.

Needs of the people:

- Library
- Right for the house
- Bus stop with place to sit
- Public toilet
- Proper sanitation for school



- Hospital with all facilities
- EB office
- Post office
- Upper tank
- To increase ration shops
- Police station, increase frequency of police rounds

Plan of action

To address issues and voice for it a sangam should be formed and registered. The sangam should be service minded not money motive. The sangam should be trained in filing RTI petition and complain letter, how to get signature from authorities, members be the one to voice out.

STAKEHOLDERS' DIALOGUE: PROMOTION OF DECENT WORK IN RETAIL SECTOR FOR YOUNG URBAN DEPRIVED COMMUNITY

On 12th October 2019, Young Urban Women and Thozhamai Staff participated in Stakeholders dialogue: Promotion of decent work in retail sector for young urban deprived community. Our Young Urban Women addressed the work should be flexible and decent work for us, the work place should be near the community so that the travel can be less. Stakeholders from GRT, Reliance Trends oriented about the work they can offer to the community. Living wages for decent life standards was taken by the Ms.Ramapriya Gopalakrishnan, Advocate oriented about ILO Geneva,

TRAINING ON SECONDARY LEVEL LEADERSHIP

On 21st December 2019 and 23rd December 2019 Thozhamai conducted two days training on Secondary level leadership for Young urban Women. On first day (21st December 2019) training Around 34 Young women participated in the programme. The recourse persons were Mr.Thenpandian, Senior Advocate and Ms. Selva. The objective of meeting is to train and strengthen the group and how to lead the group in a positive manner. Through these training young urban women gained knowledge about how to manage the groups.

On 23rd December 2019, the second day leadership training conducted in Thozhamai. About 30 young urban women participated in the programme. The resource person for the training was Mr. Thenpandian, Senior Advocate and Mr. Krishanan, Street theatre specialist. The objective of the training is to educate the legal measures.

CELEBRATION ON GIRL CHILDREN DAY

On 23rd January 2020, Thozhamai Conducted Celebration on Girl Children Day. The main objective of the programme is to create **Awareness on Gender Equality in the Community.** The society has been fully discriminated girls, Girls has been fit to be inside four walls has to break this stigma this theme has been organized for Girl Children Day. Around 150 women and children together participated in the programme. Ms. Belinda, CBO leader, Thozhamai and Ms. Mahalakshmi, ICCW were the resource person for the programme.

AWARENESS ON RIGHT TO ACCESS TRANSPORT - FGD

On 24th January 2020, Thozhamai conducted Awareness on right to access transport for women. Around 11 women leaders participated in the Awareness on right to access transport. The main objective of the FGD is to what kind of transport you require. Comparing to green board bus the white board bus is less so filing RTI makes the information clear. So through RTI and filing petition can advocacy with government and increase the bus facilities.

AWARENESS ON PROTECTION OF GIRL CHILDREN

On 27th January 2020, Thozhamai conducted awareness on protection of girl children. Ms. Sowmiya, Programme Assistant, **Child Line** gave awareness to Women leaders in the Community. They addressed How to protect girl children and acts for girl children. 12 women leaders participated in the Awareness on protection of girl Children. What are the help lines for women and children explained to the women?

DOMESTIC WORKERS RIGHT TO DECENT WORK, SOCIAL PROTECTION & INCLUSION IN LABOUR LAWS

On 4th February 2020, Thozhamai 5 Young Urban Women Leaders Participated in domestic workers right to decent work. Ms. Sujata Mody, President of women workers movement, Dr. Nantha Gopal, IAS, oriented about decent work. The objective of the meeting is to educate them about the Labour Laws to the Workers.

YUW LEADERS TRAINING

On 6th February 2020, 15 young urban Women leaders participated in training on Job opportunity through Azad Foundation. Azad foundation is an organization promotes women to

work and to drive cars. They oriented about the job opportunity and criteria 18 years to 35 years old. And they should pass 8th Standard

ONE BILLION HANDS RISING

On 12th February 2020, Thozhamai associated with Field Work students in Hindustan University, Mcc, Loyola College Presidency from in partnership with ActionAid conducted One Billion Rising for ending all forms of violence against Children and Women. Ms.J.Gajalakshmi, JAPU Police Inspector and Ms. Manju, Gunidy Inspector, Ms. Sunitha, Programme Officer-ActionAid oriented on the theme to raise the vibration for revolution and acts related for protection of women. They also oriented for getting access to Kavalan - SOS application for women safety. About 200 women have Semmencherry community participated in the programme.

WORKING WOMEN AND LAND RIGHTS

On 15th February 2020, Thozhamai 5 young urban women participated in Working women and land rights held in Stella Maris College. The objective of the programme is discussing the issues of land rights in Urban Areas and in resettlement area. Our young urban women shared the housing rights issue in resettlement area.

PUBLIC HEARING ON IMPACT OF LIQUOR AND DRUGS ON WORKERS FAMILIES

On 29th February 2020, Thozhamai participated in Public hearing on impact of Liquor and drugs on Workers families. Our 5 young urban women and 3 adolescent boys' leaders participated in the programme. The main objective of the programme is how the liquor and drugs spoil the family and affects them.

CHILD RIGHTS

CHILDREN COMMUNITY CONSULTATION

Through this activity we are identifying the issues related to women and children in urban space in the context of forced relocation and violence against young girls and women in the urban relocation site. In TamilNadu the government evicted the people and forced relocation. Most victim of this eviction is women and children. This consultation on issues related children and women in urban space main aim is to create violence free communities for women, children and bring out the issues to the outer society. The activity main aim is to create sustainable livelihood to the relocation site.

CHILDREN ACTIVITY CENTRE – ANNUAL DAY

Thozhamai organized Annual Day programme for Children Activity Centre. From 5 centres the children participated in drawing competition and dance programme was conducted in Thozhamai. Following the competition the gift were disturbed and cake cutting was conducted in Thozhamai. The children were happy and shared their experience in Children Activity Centre

AWARENESS PROGRAMME ON EYE DONATION – NETWORKING WITH BHUMI

Thozhamai organized Awareness on eye donation for children who is participating children activity centre. The resource person was from Jeppiar College and Bhumi. The main objective of the awareness is to create the importance of the body parts and the use of parts after death. The awareness programmes were projected by video and the children were clear about eye donation.

AWARENESS PROGRAMME ON CHILD SAFETY

Thozhamai organized Awareness programme for Children who are in Children Activity Centre. The resource person were Ms. Kanchanna, She orientated about the Child safety measures and how to address the abuse in the community.

AWARENESS PROGRAMME ON EDUCATION

Thozhamai organized Awareness programme for Children who are in Children Activity Centre. The resource person were Ms. Kanchanna, She orientated about the importance of education and bringing out their aim. It conducted through many activities

STATE LEVEL ADOLESCENT CONSULTATION ON END CHILD MARRIAGE

Our adolescent boy and girl who are leader of adolescent group participated in "State level adolescent consultation on end child marriage" in YMCA. The training was conducted for two days in YMCA. The main objective of the adolescent consultation was end child marriage – A child rights Violation, causes and consequences of child marriage.

ANTI CHILD LABOUR DAY

Thozhamai organized World Day against child labour in Semmencherry on June 12th 2019. 100 children participated in the program followed by human chain and slogans. The main objective of the program was to abolish child labour and give quality education for children. Through slogans the children insist importance of education and child must study and must not work as child labour. All the children participated in the programme did their pledge "Together build a brighter future without child labour".

AWARENESS ON CHILD PROTECTION

On 6th July 2019, Thozhamai organized Awareness on child protection for children. Around 30 children participated in the Awareness programme. The major objective of the programme is to create awareness about child protection. What are child protection, safe touch and unsafe touch for girls (LRP).

The awareness programme was conducted through activities and games for children. And even story telling was projected to the children to ensure the children can understand easily.

NEIGHBOURHOOD CHILD PROTECTION COMMITTEE PLANNING MEETING

On 29th June 2019, Thozhamai organized meeting on Neighbourhood child protection committee forming in Semmencherry. The resource person is Mr. Devaneyan, director of Thozhamai and Mr. Krishnan, 30 officials from various departments like health department, child protection department, Chess-Childline, Aware, urban health centre, NCPL, Thiruvalur sagam, Trade Unions, local Sagan, CBO members, Parents group and youth group boys & girls participated in the meeting. The motive of the Neighborhood Child Protection committee is to ensure protection of child from all forms of violence and abuses in Semmencherry. To protect children from all forms of violence and abuses happening in Semmencherry mainly at schools, park and even at house.

The goal of the meeting is to create a better place for children with the help of the people living in neighborhood. People from the community, different organization or institutions and higher official attended the meeting. Mr. Devaneyan, Director of Thozhamai NGO addressed the gathering. He discussed the importance, significance and need for the formation of NCPC in Semmencherry. He listed various facts on the problems of children such as:

- Children were facing problems since World War II and still this situation still continuing as we can see it in 117 deaths among children in Bihar.
- Children and women were suffered more during Tsunami, 2004 and in the same year 94 children in primary school in Kumbakonam died due to fire accident.
- 17% of child marriage is occurring in India of which Chennai has the highest rate comparing other cities of India.
- Many children in Tamil Nadu were sold for money.
- High drug usage is found among school going children of Semmencherry.
- Various diseases and health related issues are occurring among children due to mal nutrition.

Suggestions given during the meeting:

To plan a meeting including different NGO's and institutions.

- To select an avenue or a street and take enough care of all children related issues through this NCPC and within a period of 5 years to make Semmencherry a safe place for children.
- A core team includes a child- help line officer, doctor, youth members (1 boy and 1 girl).
- People who witness any child related issue can use the child-line number 1098.

The meeting concluded with a note by Mr. Devaneyan that a temporary team to be formed to plan for the betterment of NCPC for the well-being of the children in the Semmencherry community

CHILDREN ACTIVITY CENTRE

The child activity centre is based on informal education which is given to the relocation area children between the ages of 8years to 13 years old. Through this child activity centre we educate the children in activity based study. Example: Life skills, drawing, video session and storytelling. There are 5 child activity centres where in each group 30 children will be coming to the children activity centre.

There are 5 centers' where are operating in Semmencherry where all centre has been filled with children. Our LRP children are also coming to children Activity centre they don't have space to study at home.

Achievements: One of the children activity centre is running exclusive for manual Scavenging children and gypsy children. Other caste people came and shouted in the centre not to admitted Manual Scavenging workers child. At last we decided to start a centre exclusive for Manual Scavenging children inclusion of others.

NEIGHBOURHOOD CHILDREN PROTECTION COMMITTEE

On 19th July 2019, Thozhamai conducted Neighbourhood children protection committee in Semmencherry. This Neighbourhood Children Protection Committee is one of the follow up meeting of the last meeting. This meeting was headed by Mr. Kumarasan Chess- Childline, he orientated about the child protection measures and how to handle through Neighbourhood Children Protection Committee. Around 16 officials attended Neighbourhood Children Protection Committee. The committee members discussed some of the common problems faced by the children in Semmencherry and in the Schools. Certain common problems has mentioned below

- Drug usage at community and even in the schools. And the teachers are not aware of children using drugs at schools
- School drop outs
- Child Marriage

- Most of the children in relationship and they are getting married
- Gang war among the children
- Child Labour

Mr. Kumaresan, Chess-Childline Mentioned how to address the problems to the government and public. He mentioned some of the measure to be handled like

- Draft a petition if we have to refer the child to the hostel (CWC) to welfare officer. The legal guardian can give a complaint if the petition is not answered.
- Follow the entire petition which is given by the community members through the committee letter pad. We have to create a separate letter pad for our Neighbourhood child protection committee.
- Education Advocacy, Giving awareness to schools about child protection
- Give awareness to children activity centre and their parents, so that they can give awareness to their neighbours
- Public awareness
- Parents sharing the children problems
- Addressing the drug usage in media
- Address if any violence happened against children to the police department or commissioner office
- Create awareness through Street theatre
- Awareness for Teachers about child rights and child protection

Some of the major discussion has mentioned below.

- One day training has been fixed for Neighbourhood Children Protection Committee for committee members on 17th August 2019
- Fixing the committee members at 17th August 2019

Invite the school headmaster through Chess- Child line

AWARENESS ON CHILD PROTECTION IN COLLABORATION WITH POLICE COMMISSION

On 3rd August 2019, Thozhamai participated in Awareness on child protection in collaboration with police commission. The major objective of the programme is to safe guard children from the violence. It followed by rally in Besant nagar beach and our 20 Semmencherry children participated in the programme.

AWARENESS ON CHILD MARRIAGE

On 24th August 2019, Thozhamai conducted Awareness on Child Marriage. Thozhamai in network with Youth for Advocates (UNICEF) conducted street theatre in the community to bring awareness on child marriage. They addressed how to stop child marriage in the community. Around 150 direct beneficiary and 300 indirect beneficiaries got benefitted through street theatre

SHOUT CAMPAIGN

On 24th August 2019, Thozhamai conducted Shout Campaign in Semmencherry for children. The major objective of the programme was freedom from child trafficking. Around 40 children participated in the Shout Campaign and MCC shout team conducted the programme.

TRAINING FOR MOTIVATORS – AIDINDIA

On 24th August 2019, Thozhamai conducted Training for Motivators. All motivators participated in the training. Aidindia provided training to motivators and they provided training for other motivators. The main objective of the training is to educate them children actively and in easy way.

The programme was conducted by the Adolescent boys' group leader, Mr. Lokesh and their group. The main objective of the programme is to spread avoid crackers and build an environment healthy and clean. If the children burst crackers means how to be safe with the fireworks has been oriented by the Adolescent Group leader.

AWARENESS ON CHILD HELPLINE

Thozhamai in collaboration with Chess Child line organized 'Children's Day Celebration' through creating **Awareness on Child Helpline** in Semmencherry for children. **100 children** participated in the programme and took an oath about importance of education and yes to education, **Ms. Kanchanna, Sponsorship Coordinator** headed the programme. And children did tree plantation in the area creating awareness on Child Line.

ADOLESCENT BOYS AND CHILDREN - FOCUS GROUP DISCUSSION

On 6th November 2019, Thozhamai conducted Focused Group Discussion on the problems faced by the Children and Adolescent Boys in the schools.

QUALITY OF EDUCATION

Focused group discussion was conducted in Semmencherry for Children. The following groups has been conducted

- Boys group Middle school, Semmencherry
- Boys group High school, Semmencherry
- Girls group High School, Semmencherry

Totally 40 children participated in the focused group discussion. The group has been asked that question. The questions are mentioned below.

FOCUSED GROUP DISCUSSION ANSWER

Learning & Teaching

- 4. Children are buying tea and snacks for teachers during class hours. Children are cleaning teachers lunch/Tiffin box
- 5. Tamil and English medium classes are been combined together
- 6. Teachers are talking very bad words to children
- 7. Teachers are giving punishment to children and discriminating the children through the area stigma
- 8. Punishment are been given differently to each gender. Boys are given serve punishment and girls doesn't get punishment
- 9. Other NGO's conducting extra circular activities in the school
- 10. Male teachers are asking girl students why you are coming to school go and get married.
- 11. No parents teachers meeting happening in the school
- 12. There is SMC in the School, there no proper functioning, teachers doesn't have clear knowledge about role and responsibilities about SMC

Infrastructure

- 1. CCTV camera near schools and public places to avoid violence in the community
- 2. There is no playground
- 3. There is no Science lab in Schools
- 4. Lack of water, no running water facilities at school restroom
- 5. No trees in the schools
- 6. There is no fan/no current
- 7. No sports material
- 8. There is no space to eat in school because there is no trees in the school
- 9. Previously there was a building to eat in the school but now they destroyed the building and renovated as a class room

- 10. Toilet is dirty
- 11. Children are cleaning the classroom

- 13. Only teachers has fan in the classroom the children does not have fan
- 14. No light in the classroom
- 15. Mid day meal is given between the class from 1 to 10, Mid day meal is not clean, we have stone, worm inside the food, rice

Recommendations (Children)

- 1. Need proper mid day –Meal scheme at school, clean food
- 2. Need library, fan, light playground at school
- 3. Teachers must be friendly and they must not compare us and they must not discriminate us in basis of community
- 4. Need adequate teachers at school

WORLD'S CHILDREN DAY

World Children's Day on behalf of 14th November 2019, Children's day and 20th November 2019 World Children's Day conducted in Semmencherry.

300 Children and 200 women and men participated in the programme. Mr.Aravind Ramesh,MLA, Ms. GajaLakshmi, Inspector, Ms.Sridevi,Inspector and Uvrani,Inspector from Police department on Crime against children and Women, Mr. Devaneyan, Director and Mr.SathyaMoorthi,ActionAid were the chief guest for the programme.



Crime Amma Patrol was displayed to the public. Ms. Uvrani Inspector explained needs of Amma Patrol to the public. Young Urban women and Women submitted Petition to Mr. Aravind Ramesh, MLA regarding the issues in Semmencherry. They educated them about Child Safety to the public.

Street play was conducted in Semmencherry by Kalieshwaran Team. The theme of the street play was to address the Child Abuse and Child Protection.

TRAINING ON NEIGHBOURHOOD CHILD PROTECTION COMMITTEE

Thozhamai Conducted Training on Neighbourhood Child protection committee team (NCPC team) in Semmencherry on 18 December 2019. 40 officials from various departments (District Children Protection unit, Health department, Child Line, ICCW, Youth group leader, Young urban women leader, participated in the orientation programme. Mr.Thenpandian, Advocate and Mr. Devaneyan Arasu emphasized on importance of child protection and Child friendly environment in the community. They also highlighted about laws related child protection like Juvenile Justice Act, POCSO Act and legal mechanisms to protect children

The following objectives have been carried in the training.

Introduction - Mr Devaneyan, the Director of THOZHAMAI

Some of the highlighted issues have been addressed to the gathering like the infanticide happening in Thiruvannamalai district and about the children being trafficked in various places. He mentioned a case of a 14-year child being sexually abused by 16 men in Ayanavaram. In the year 2018 around 189 child marriage cases have been filed, In Chennai comparison to other metropolitan cities there are more violent Is happening against the children and women. He quoted and presented several incidents of child labour, child abuse and trafficking with facts and data.

Speaker - Mr Thenpandiyan, Advocate

He quoted that in 2013 the state have stated that the Child is a National Assert of their country, where he mentions the age of the child is under 18, who ever belongs under the age of 18 are called as the children.

According to the law the children are

- Innocent
- Dependent
- Vulnerable
- Big constituency

According to the census of 2011 45% of the populations are children.

He gave a reference about *UNCRC- United Nation Convention on the Rights of the Child* which was amended in the year 1989 on November 20 that protects children and young people. He involved the students in repeating the four sets of the *fundamental child rights* such as,

- Right to Survival
- Right to Development
- Right to Protection
- Right to Participation.

He also spoke about the PCPNDT Act, is the discrimination of the girl child.

He also spoke about certain laws and acts namely, The *Prohibition of Child Marriage Act*, **2006** and **POCSO Act (Protection of Children from Sexual Offences Act)** in order to bring awareness among the people of the community.

He spoke about the punishments for the crime that have been done against the child are

- Prohibition of child marriage, 2 years of prison and 2 lakhs of fine.
- Rape, POSCO act 2012 if the child is below 18 is been raped the punishment would be 20years of prison.
- If a primary Duty Barriers attempts rape they would be given 10yrs of prison.

Juvenile Justice Act:

He spoke about the three major parts of the Act they were:

- Care and Protection
- Conflict with law
- Adoption

These are the major roles of the act. At last he spoke about the Right to Education where every children in the community have the right to educate themselves but due to the surroundings and peer group they do not get the right properly.

End of the session where everyone was put with some groups and Each group were asked a question like a particular kid is been under this Problems what will be the steps that'll taken and each group answered it as it was a input from the session which was connected before. After the question session sir wanted everyone to raise up and sing a song what he had written for the children' and everyone were happily singing the song

With the enthusiasm the session came to an end with the group picture.

The meeting would be continued in the upcoming days to form the NCPC COMMITTEE.

The committee should have an elder person, a Youth person, a doctor, a teacher and an auto driver

This committee would be formed later in the upcoming days after a clear discussion with the people of the Semmencherry community.

CONSULTATION ON CHILDREN ISSUES IN URBAN SPACES TO END ALL FORMS OF VIOLENCE AGAINST CHILDREN

Thozhamai jointly organized with Mohamed Sathak College of Arts and Science, organized Consultation on Children issues in Urban Spaces to end all forms of Violence against Children for the students of Mohamed Sathak College of Arts & Science on 19 December 2019. The key members of the programme are Thenpandian, Devaneyan Arasu, Isai Arasu, Dr.A.Purushothaman, Vice - Principal, Mohamed Sathak College and Mrs.V.Vijaya, Women's Cell. They emphasized the importance of role of protection and promotion of child rights in urban spaces to End all forms of violence against children. About 300 students participated in the programme

The programme was exclusively organized for the girl students of Mohamed Sathak College in view of bringing awareness on child issues.

Introduction - Mr Devaneyan, the Director of THOZHAMAI

He highlighted the issue of infanticide happening in Thiruvannamalai district and spoke about the children being trafficked in various places. He mentioned a case of a 14-year child being sexually abused by 16 men in Ayanavaram. He quoted and presented several incidents of child labour, child abuse and trafficking with facts and data. There was an invitation given by him to the students to read the society and be aware of the realities around them. He encouraged the students to conduct motivation classes for the children; to do advocacy- be the voice of the voiceless; and to safeguard the rights of children. It was a thought provoking and powerful speech.

Speaker Mr. Isaiyarasu – Activist

He began his talk by quoting Dr Ambedkar that the nation is divided into two- one is for the untouchables and the other is for the so called dominant caste. He made the students aware of the actual situation and untold stories of the children of Semmencheri, Kannagi Nagar, Perumbakkam, and Ezhil Nagar. They lack the aspect of education; some travel a long distance to the schools skipping morning meal; a few become child labour; and some remain idle and make their lives desperate.

Ms Lavanya (YUW from Semmencherry)

She highlighted the problems faced by the children of Semmencherry due to the forced eviction. The problems such as,

- Lack of School
- Dropout children
- No playground
- Lack of safety and security
- Need of a library

Speaker - Ms Sarojini (YUW from Perumbakkam)

She focused on the problems and needs of the children in Perumbakkam. They are,

- Stagnation of water
- Need for more Anganwadi
- Need of a police station
- Need for an awareness on Sex Education

Speaker - Mr Thenpandiyan, Advocate

He made his talk very jovial and interactive. He highlighted about the People's Welfare State and informed the students whom to consult and approach for any problems regarding the welfare of people. The focal point of his address was about the 'Golden Triangle' of the Indian Constitution that declares India a sovereign, socialistic, secular, democratic, republic nation.

- Article 14- Equality before the law
- Article 19- Right to freedom
- Article 21- Right to life with dignity

He said, "Equality is in law, but not in practice". By this statement he insisted how people are discriminated and children are tortured. He mentioned that amidst 7.5 core population in Tamil Nadu 40% are children who lack the privileges given by the constitution. He gave a reference about *UNCRC- United Nation Convention on the Rights of the Child* that protects children and young people. He involved the students in repeating the four sets of the *fundamental child rights* such as,

- Right to Survival
- Right to Development
- Right to Protection
- Right to Participation

He said, "Infanticide is nothing but the rights of the children are killed in the womb of a mother"

He also mentioned certain laws and acts namely, The *Prohibition of Child Marriage Act, 2006* and *POCSO Act (Protection of Children from Sexual Offences Act)* in order to bring awareness among the students.

Finally, he gave a call for action to become advocates and spread awareness amidst the children and people living in ignorance.

Ms Lilly Margarte, the City Coordinator of THOZHAMAI

She gave the students clarity on the theme of the day and invited everyone to be a change maker and to create awareness in schools, colleges and so on. She said that training could be given to the interested students who are willing to be the agents of change.

She finally mentioned the helpline numbers,

- Child helpline- 1098
- Women helpline- 181, 1091

She also mentioned about the Pink Patrol and Thozhi Scheme that exclusively address the issues of children and women.

The Consultation on Child Issues was concluded with a proposal of vote of thanks and a call for students to become the agents and instruments of change.

AWARENESS ON IMPORTANCE OF EDUCATION

On 27th January 2020, Thozhamai conducted Awareness on importance of Education for Adolescent boys. Around 20 adolescent boys in Government High School in Semmencherry participated in the training. Ms. Kanchana, Sponsorship Coordinator gave awareness on Importance of education. Only education can make the future bright and lead the life into perfect path.

AWARENESS ON RIGHT AND ACTS ON CHILDREN

On 29th January 2020, Thozhamai conducted Awareness on Right and Acts on Children in Government Middle School in Semmencherry. Ms. Gajalakshmi, Inspector, Crime against children and women, Ms. Kanchana, Sponsorship Coordinator, Thozhamai and Mr. Prasanth, World Vision were the resource person for the programme. They POSCO Act, Basic child rights were given awareness to girl Children, Around 100 girl children participated in the programme.

NCPC AND PARENTS MEETING

On 15th February 2020, Thozhamai conducted NCPC meeting and parents meeting. A new NCPC group formation formed in 5th Avenue to ensure child protection in the community. Around 18 members participated in the meeting. Ms. Kanchanna oriented about the importance of NCPC and how to form a NCPC in the avenue. This is the first NCPC committee in the area.

ADOLESCENT BOYS GROUP MEETING

We formed an Adolescent group formation (Boys). The main objective of the Adolescent group formation (Boys) is to create sports and develop them in sports. On 1st may 2019 Thozhamai conducted adolescent boy's group meeting in Semmencherry. The main aim of the Adolescent boys group to encourage sports among them and teaching life skills through this we engage them and promote education for all in Semmencherry. The Adolescent group (Boys) has 15 members. We had a meeting regarding what type of sports have to be conducted for them.

ADOLESCENT BOYS TRAINING

On 08th May 2019, 09th May 2019 and 10th May 2019 Thozhamai conducted three days continues training for adolescent boy's group meeting in Semmencherry. The main aim of the Adolescent boys group to encourage sports among them and teaching life skills through this, we engage them and promote "education for all" in Semmencherry. About 15 adolescent boys of group one participated in the training following two groups participated in the further training as per the meeting discussed earlier. On first day adolescent boy's group training focused on the Physical and Mental Changes occurs in the adolescent age, the first day training focused on how to handle and control the mental changes during the adolescent age.

On 09th May 2019 the Adolescent boys training focused on the importance of education through activities and basic rights. The training took place for half day; Ms. Kanchanna was the resource person for the training. The adolescent boy's learnt about the basic rights.

On 10th May 2019 the Adolescent boys training focused on the importance of personal hygiene and how to take care of them during summer season and the importance of sports.

On 26th December 2019, Thozhamai conducted an awareness programme on addiction towards Drugs. The target group was adolescent boys of the Semmencherry community. 16 boys were participated in the programme. The training was conducted by Social Worker.

AWARENESS ON HARMFUL DRUGS

Awareness on drug abusers was explained through many motivational videos. They also explained about the ill effects of drugs and measures that are available to overcome the addict.

It helps to analyze that people of the community get addicted to drugs due to stress and depression. To balance these mood swings, trainees also conducted life skills on positivity.

Outcome of the programme: adolescents got the information about the causes of drug addiction and also understood the effects of drug addiction. Through the life skill training, target group understood about staying positive and to control their mood swings. On the whole, the session was useful to the target group and each person got benefited.

LIFE SKILLS TRAINING - ADOLESCENT BOYS

On 02nd January 2020, Thozhamai Conducted Life Skills Training for adolescent Boys in Semmencherry. Around 14 adolescent boys participated in the training. Mr. Gowatham, Throw ball Coach was the resource person for the training. He conducted life skills on the topic health and followed by importance of sports. He trained the adolescent boys about the basic throw ball in Semmencherry Ground.

YUW SUBMITTING PETITION TO MR. ARAVIND RAMESH, MLA

Young Urban women Association, Thozhamai in Semmencherry submitted the petition to Mr. Aravind Ramesh, MLA. TamilNadu Slum Clearance Board, Managing director, Mr. Aravind Ramesh, MLA, Water department and other official department visited Semmencherry to check

the basic facilities in Semmencherry.



Our Young Urban Women submitted petition regarding the lack of library to be located in Semmencherry, to build upper water tank to avoid water issues, drug abuse in Schools, upgrade the hospitals and to provide CCTV camera for women safety. Our Young Urban Women asking Mr. Aravind Ramesh, MLA for livelihood opportunities in Semmencherry. Because the shops have been maintained by the outside area

people where there is no opportunities for our people to keep their own shops. Young Urban Women suggested and requested to keep shops for them to create a better livelihood.

ADVOCACY WITH STATE LEVEL WOMEN COMMISSION Thozhamai along with Young urban women from Semmencherry Conducted **Human Rights day & 16 days of Activism of gender based violence on 10th December 2019**. 30 Young urban Women submitted memorandum on

women and children safety in prevention of harassment from Community to **Ms. Kannagi** packianathan, IAS (Retd) Chairperson of Tamilnadu State Commission for women. They urged to take preventive measures to end violence against women in the community. The issues are mentioned below

The major issue of women faced in Semmencherry is they do not have clear idea of which district they actually belong to, due to this unstable condition, people face difficulty to proceed to the right Government office for availing pension, submission of petition and other corporation issues.

The Women Commission Chairman immediately called Chengalpet District Collector and addressed these issues immediately. The Women Commission Chairman addressed the issues to the officials and told to setup a counseling centre in Semmencherry. So that it will be helpful for women who are depressed due to their violence. The other issues like caste discrimination that leads to deprivation of education to the children.

The officer had a detailed discussion with the Thasildhar, District Collectors, and counseling units and also assured that once she will be visiting the community to receive the director petition from the community people.

ADVOCACY WITH CRIME AGAINST WOMEN AND CHILDREN WELFARE WING (POLICE DEPARTMENT)

Thozhamai along with Young urban women from Semmencherry Conducted **Human Rights day** & 16 days of Activism of gender based violence on 10th December 2019. 30 Young Urban Women submitted memorandum on women and children safety in prevention of harassment

from Community to Tmt.Jayalakshmi, IPS-Deputy commissioner of Police (Crime against children and women) on 10 December 2019

Representatives of the community placed their request to eradicate the hindrances such as

- lack of proper education to children
- women harassments of the road sides
- illegal distribution of drugs
- consumption of drugs by children



On the account of these issues, Ms. Jayalakshmi IPS addressed the problems immediately by implementing the **Safety Walk** project in the Semmencherry community, the project was about the survey on the livelihood of the community and also violence against women and children. This survey sheet had eight questions about the environmental maintenance, infrastructure, safety, schooling and education, police patrol this survey was taken by members of the Thozhamai to the general public of the community. From this survey the team was able to analysis the pathetic condition of the community where they lack in:

- Proper street lights
- Children deprive of education
- Safety for women and children
- Sanitation

On the submission of the survey to the IPS, the official assured for the safety for women and children and to eradicate the crime that takes place against women.

The community women explained what are the problems occurs because of the network and what are the things which is lacking in the community for that network officials answered to the community.

CAPACITY BUILDING TRAINING FOR STAFF

Thozhamai conducted capacity building training for staffs in the organisation. The resource person Ms. Kanchanna and the training were conducted in the venue at Semmencherry office. The main objective of the capacity building training was focusing on challenges faced by the staff and personal sharing about the project.

CAPACITY BUILDING FOR STAFFS - PHOTOGRAPHY

Staff Capacity building Training focusing on Photography the resource is Mr. Deepak from Negative Space who has 10 years experience in photography. He took his passion in photography and working in Cinema Field. The photography training topic is focusing on capturing Social and economical vulnerability of the people. All staffs participated in the training and the training focused on the basic camera rules. He also orientated about how to see a photograph without a commercial purpose. The photograph of the people should be original as it is and also we must not see the people as commercial because the political economy of the society is very poor comparing to other countries society. He taught the basic camera

which is



mentioned below.

1. Aperture

- Exposure happens in three steps. We will start with the aperture. This is the hole inside the lens, through which the light passes.
- It's similar to the pupil of your eye: the wider the aperture, the more light is allowed in and vice versa.

- As the aperture widens, the f/number gets lower and more light is allowed into the camera. This is great for low light but be aware that it's going to make the depth of field very shallow not ideal when taking landscapes.
- The aperture is the preferred setting to set first, as it directly influences how much of your scene is in focus. But, if you are looking to create motion blur, then it is second to the shutter speed. Exposure will be much easier if you can memorize the f/stop scale.

2. Shutter Speed

- Once the light has passed through the aperture of the lens, it reaches the shutter. Now you need to decide how much of that light you're going to allow into the camera.
- Ordinarily, you only want a very small fraction of a second (for example 1/250) to prevent motion blur. However, different shutter speeds complement different situations.
- Anything from really fast (1/4000) for sports photography to really slow (30 seconds) for night photography. It all depends on what you're shooting and how much light you have available to you.
- Knowing how your shutter speed works is a key element in the basics of photography.

3. ISO

• Once the light has passed through the aperture and been filtered by the shutter speed, it reaches the sensor. This is where we decide how to set the ISO.

How to use the Kavalan - SOS app?

During an emergency, please press the SOS button on the home page. It will start a 5 second count down. After 5 seconds, the app will automatically send your current location along with a video from your back camera to the Kavalan team. Within a minute, the team will contact you. Simultaneously, your location will also be sent to your registered emergency contacts as an SMS alert.

Ms. Sumithra, Community Mobilizer is the resource person, who took over the session and educated the adolescent girls about the menstruation cycle and their needs. The main objective of the menstrual hygiene day is to women need to access to clean materials for menstrual hygiene.



INTRODUCTION

The Goal Program was started in 2014 in Thozhamai Organization, Chennai. The program mainly focuses on adolescent girls to improve their Economic empowerment between the **age** of 12 to 19. This program was implemented in Schools and colleges to make awareness to adolescent girls. This program made many girls to achieve in sports field and also in life skills. Through life skill the adolescent girls became more strong and growing self confidence.

The 7th ONNC match was conducted in Thiyagarajan stadium at Delhi on 29th April to 1st May 2019, before the match we conducted the camp and gave netball practice to the players for 13 days. Those 13 days the players were worked hard along with Goal staff and the CSC's also came and played with the players, and said by they also had the opportunity to have match, and the parents were also supported well and visited the camp.

Every day 2 times we practiced the players that is **Morning (6.30am to 9.30am) & evening (2.30pm to 5.30pm)** with nutrition refreshments like Banana. After the camp the players were got ready for the match. Then the last day of the camp Mr.Devaneyan (Director), Mr.Balaji (Ad minor & Financier), & Mrs. Lilly (City coordinator) were met the players and talked about the Match and travel then they motivated, wished them for the match. **7th ONNC Match**

The ONNC match was conducted at New Delhi. Totally **10 participants, two coaches and one parent** were gone to the match. We started our travel at 10.30 pm at Chennai central on 26th April 2019 and we reached New Delhi on 28th April 2019 at around 9.00am. After reaching we have done the registration session, and then we took rest. After some time the players had **Child Policy Protection (CPP)** session. In that session the players were from different places did the activity which was conducted by Naz Delhi CSC. Totally 18 teams from different state were came for the ONNC match. Then we all went for the India gate there we spent 40 minutes just for the relaxation. Again we came to the Hostel. Then we had the coaches meeting, in meeting we were discussed about the next two days plan, food timings, Match timings, Raising stars

team and super star teams and all. Then we all had dinner and went o the bed. So the first was successfully gone. The next day 29th April was the first day of the match, it was started at



9.30am at Thiyagarajan stadium. On the first day we had match with three teams, we won two out of three. Then the next day we had match with four teams, and we won three out of four. At last the final we had the pre quarter match, we had match with two teams and we loosed with one team so we couldn't get placement, but this 7th ONNC match had the different experience to every player and coach.

After all these again we started our journey from Delhi central on 1st May at 10.30pm, travelled over one day then we had players' feedback and experience sharing in the train on 2nd May at 10.00pm. Then next day 3rd May we reached Chennai central by 8.30am. Our journey was very successful with safety.




Planning meet for formation of UNICEF ON CAMPUS CLUB at Stella Maris College on 24 June, 12 July and 24 July 2019.

Movie Screening and Panel discussion on "Period - End of sentence" associated with US consulate, Netflix, UNICEF and SPI Cinemas on 31 July 2019.

On the 31 July 2019, Annette Haveela Joseph from Social work department of Stella Maris College was invited to speak in a panel discussion which was jointly organized by the US Consulate, Netflix, UNICEF and SPI Cinemas. The panel discussion was to follow a movie screening in SPI Cinemas, Royapettah. The award winning movie 'Period – End of sentence' was screened. The movie is about a group of women from a small village who installed a pad making machine to stop unhealthy menstrual product use.

The movie also covers the strong stigma attached to menstruation and how the rest of their community reacts to speaking up. After the movie was screened the panel discussion – which was moderated by Mr. MoulikBerkana, Acting Public Affairs officer, US Consulate General, Chennai – began.

Joining me on the panel as panelists was:

- Ms. Julia Burleson, a Public health student from Johns Hopkins Univ., Maryland.
- Mr. Krishnamurthy. S, Executive director, India NGO.
- Mr. Sugata Roy, Communications Specialist, UNICEF Tamil Nadu and Kerala

Each of us spoke about our role in eradicating issues pertaining to Menstrual hygiene, such as lack of awareness, lack of proper sanitary products etc.,. I got the opportunity to speak about how as a student of Social work and a Youth advocate for children, I could contribute towards making the environment safer for women and girl children when it comes to menstruation. I spoke about how, during field work visits to schools, we as students have organized and conducted programs on menstrual hygiene to girl children. Also about how, in Co-educational school settings, we addressed the boys as to how it's important to respect what women in their families as well as their female student counterparts are going through.

I also spoke about how every time the session ends, there have been students who come up and tell us how much confident they've become now about talking on menstrual hygiene and also how they will take care of themselves from there on. It was a platform for me to voice my ideas and plans toward reaching out to unaware female population in highly rural areas. Through this event I had the opportunity to collaborate with members of the US embassy, prominent media personalities and also the founder family of a prominent transport company for future work endeavors. Also I was self analyze and come up with ideas to create a healthier and safer sanitation facility filled life for rural women. Overall it was a great opportunity for me to share my experience in promoting healthy sanitary education and also to speak about how I was able to break the taboo, if not at a big level, but at least in the smaller part of the community.





Inaugural orientation programme of UNICEF on Campus (UOC) Club at Stella Maris College on 1 August 2019

The orientation programme begun with journey of YA4C since 2018:



This depicted the work put in before the formation of the club primarily by the office bearers of UOC from 2018 as of now when they were a part of UNICEF and social work students.

- The Yercaud Trip as introduced by Jenita was the beginning of their journey in May 2018 where they were a part of UNICEF and learnt more about child rights, child sexual abuse, cyber crime and tried to device an action plan.
- The RGNIYD as introduced by Annette was a youth forum to depict their work and understanding to bring changes at policy levels to policy makers on SDG's, education, WASH and safety etc.
- The Workshop on social media by Arushi Dutt as introduced by Jenita showed them to protect themselves and others from child violence and prevention of abuse on cyber levels.
- The visit to Santi Bhavan as introduced by Bala marked the journey of 60 + girls understanding sex education and menstrual hygiene by effective communication and puppetry.

- The host performance in Unnathi Forum in Stella in October 2018 as introduced by Deborah brought home the messages of gender inequality, child safety, protection and need for development.
- The TED Talk by Tryphena introduced by Tryphena marked a personal and group landmark due to online viewership. The speech was on CSA in schools and need for protection in Delhi in November, 2018.
- The Interactive session with child protection officers of Unicef was introduced by Annette in December, 2018. They were open to newer ideas, solutions and accepted the creativity and need to change.
- The Youth Symposium on ending child marriage in 12 February 2019 as
 introduced by Bala Gowri and Zerlin had their participation as panelists and
 street theatre actors to drive across the message of ill effects of early
 marriage and social and legal consequences of the same.
- Period The end of sentence as introduced by Annette held the message of menstrual hygiene representing India. There was a panel discussion in which Annette was a panelist along with Mr.Sugata Roy, Unicef, Mr.
 Krishnamurthi, India NGO, and a student from John Hopkins after a documentary on the status quo in hapur District.

Mr Devaneyan Arasu,
Director, Thozhamai - He
addressed the gathering on
the technical issues of child
safety including issues of
child abuse, child violence,
child labour and child
marriage. He also



emphasized on UNICEF and Youth advocates to be taken oath to be taken for lifetime as a responsible adult. The need of Youth Advocate begins with the powerlessness, voicelessness of children and to make every society a child centric, rights-based society.

Mr. Sugata Roy, Communication Specialist, UNICEF- He addressed the gathering about the SDG's of 2030 and how the 17th goal is partnership with others. He spoke about the failure of MDG's and the lack of youth participation. He spoke about the need to improve



supply chain management in information and sanitation facilities. He delivered the message of becoming change makers and understanding bullying, violence, being kind and cyber security.

- a. The first group presented their ideas on informing the students about cyber security, RTI and putting across a petition for online safety.
- b. The second group presented their ideas of representing the marginalized communities such as transgenders and LGBTQA + community and effective solutions to end child violence.
- c. The third group presented their ideas of improving strategies of good parenting and promoting gender equality.
- d. The fourth group presented their ideas on creating safe spaces from workplace harassment, bringing awareness and moderating discussions on this topic in and out of Stella.
- e. The fifth group presented their ideas on helping spread the message of abuse and voice out bullying and sexual abuse with effective communication thereby removing stigmatisation and stereotyping.
- f. The sixth group presented their ideas on developing anonymous support groups funding a child and social media literacy.
- g. The seventh group presented their ideas on ending child marriage, and celebrating children for their innocence.
- h. The eighth group presented their ideas on bringing forward support groups, education forums, teaching creative art therapies and funding or referring children for education.
- i. The ninth group presented their ideas on ending child violence in schools by bridging communication and ending stereotypes, child marriages and empowerment by educating.

Street Play on violence against children at Mohammed Sathak College by UOC team of Stella Maris College on 7 August 2019 & Campaign against child marriage at Semmencherry by UNICEF Youth Advocates on 24 August 2019.

This Campaign against CHILD MARRIAGE was organised by Ms. Shirley pursuing her second year Post graduation at the Department of Social Work. Ms. Shirley is undergoing herfield work training with THOZHAMAI working for the marginalised communities at Semmencherry.













Child Marriage is one of the rampant social problems found in Semmencherry which is a resettlement and rehabilitation project created by the Tamil Nadu Slum Clearance Board. People who were earlier living in slums in various parts of Chennai have been relocated to the tenement houses in Semmencherry.

The UNICEF ON CAMPUS, Stella Maris College is a club that works to sensitise peopleby creating awareness on issues, abuses and violence faced by children. The YouthAdvocates sensitise people through social media and other conventional mediums like the street theatre.

Youth Advocates along with a few students pursuing their first year under graduation insocial work performed street theatre on the theme of "Violence caused to Children by Child Marriage at Mohammed Sathak College on 7 August 2019 in view of International Youth day and two places at Semmencherry on 24 August 2019.

Around 100 residents of Semmencherry were exposed to the problems caused by Child Marriage. The Youth Advocates were appreciated for their sincerity and creativity by theaudience. Many young women and mothers in the audience also expressed their views on the problems of child marriage and felt inspired to take action against Child marriage in their families and communities.

Youth Advocates Interactive Programme with Ms. Trisha Krishnan Celebrity Advocate, Unicef on CRC@30 years "End Violence Against Children at Stella Maris college on 28 August 2019

UNICEF on Campus Club, the Department of Social Work, Stella Maris College, THOZHAMAI - Solidarity for Rights in partnership with UNICEF conducted the celebration of United Nation's Convention on the Rights of the Child, 1989 - CRC@30 and commemoration of the theme "Ending Violence against Children (EVAC)" at Stella Maris College.

Youth Advocates interacted with Ms. Trisha, Celebrity Advocate of Unicef, on various initiatives taken by them such as:

- i) spreading awareness on gender equality among school children
- ii) peer education in colleges and neighborhood
- iii) using street theatre as a medium to spread awareness on child rights in developmental areas and
- iv) Educating girl children on menstrual hygiene and child marriage.

Speaking on the occasion, Ms.Trisha Krishnan stressed the need to uphold UNCRC for the rights of all children as it has been a very slow progress in the area of Child rights. In response to a few questions related to child rights were posed to her by *Youth Advocates*, Ms. Trisha answered with enthusiasm and fact. During the session, Ms. Trisha issued certificates to students who had successfully completed the online course on the topic "Child Rights and Why They Matter" hosted by AGORA (AGORA is a free portal offering tailored learning solutions to *UNICEF's* staff, partners and supporters and is *UNICEF's* global hub for learning and development)

10 points on Youth Advocates are taking initiatives to End Violence against Children

- 1. We perform street plays and skits on the various violence children faces. We use these skits as a form of peer education and to create awareness on various issues that children face.
- 2. We have started the UNICEF on Campus club to bring the students together to mobilize on the issues faced by children. Through this club we have oriented over 200 students of the college on EVAC. We plan to get more students in this club to create a large group of students who will raise their voice for children.
- 3. We as the students of the Social Work Department visit various schools in the vicinity and speak about gender equality and child abuse. After we speak to the kids they almost tend to open to us on the various problems they face.
- 4. We have started a campaign against child marriage at Semmenchery, a relocation colony in Chennai. We plan to go there regularly and perform skit against ill effects of child marriage and do more awareness drives as Semmenchery is considered to be a place for a lot of anti-social activities.
- 5. We the Youth Advocates conducted an elaborate program on Health and Hygiene for the children staying in Perumbakkam Resettlement Area. The programme was a huge success as many children from the community participated.
- 6. Six of us, Youth Advocates from the college took part in a National Conference hosted by Rajiv Gandhi National Institute of Youth Development on the SDG goal number 16 (Peace, Justice and Strong Institutions) and 4 (Quality Education) on the context of child development. This platform gave us a place where all of us could speak out Youth specific SDG goals. We were also able to voice out our ideas, opinions and concerns to policy makers of child protection.

- 7. As Youth Advocates we hosted a Youth symposium to End Child Marriage at Stella Maris College where students from all over the state of Tamil Nadu took part. Through this symposium we were able to create a massive awareness on child marriage. We plan to host more symposiums and talks around the different problems children face so that we can not only raise awareness but get the key stakeholders attention to find a possible solution to the problem.
- 8. Tryphena Being a Youth Advocate I have got the opportunity to go to Delhi and talk about child abuse in UNICEF Talks program where Parliamentarians were part of the program. Through this platform I have got the courage to go out and speak to different people about child abuse. Last year I was a part of the Independence day celebrations in a private school where I was among the panellists and spoke on how parents should react to child abuse and also on the myth busters on child abuse.
- 9. Annette I was given the opportunity to be a panelist in an event hosted by US Consulate and talk on how menstrual hygiene is a problem among young girls. I have visited many schools in various communities and spoken to young girls on the importance of menstrual hygiene. This is the kind of things that usually no one talks to these young girls. They consider these things as taboo or brush it under the carpet but I have started speaking about this as these are the common problems that we face every day and there needs to be more awareness on it.
- 10.Rebecca I have been nominated to attend the 3rd Annual Parliamentarians Meeting in Colombo, Sri Lanka next month. I will be speaking on 'what youths can do to increase their voice to create a better impact' and also on 'what governments and parliamentarians should do to ensure child rights' This platform that has given to me will help me to channelize the voice of the youths which will create a better tomorrow.

Film artist and UNICEF celebrity advocate Ms. Trisha spoke about the worrying increase in 'POCSO' (The Protection of Children from Sexual Offences) cases

that were registered from 2014 to 2016 across the country. She also quoted that "As per the NCRB 2016 report, the cases reported under the POCSO Act in 2014 was about 9,000, 2015 it was 15,000 and 2016 it has doubled to 36,000 cases and about 95% of the offenders of rape cases are known to the victim".

According to a press statement, "End Violence Against Children is a collaborative effort between UNICEF and other UN agencies, governments, civil society, young people, advocates, and champions, all focused on one thing: making the world safe for children."

their experiences. When parents do not listen to them they would look for support from outsiders which might expose to violence. Children cannot grow without the support of their parents. Children should also listen to their parents as they

Conference on South Asia Parliamentarian Platform for children – Colombo, Srilanka – 2 & 3 September 2019

This conference was held in Srilanka on September 2nd and 3rd with the participants of eight different countries such as India, Pakistan, Bhutan, Bangladesh, Maldives, Afghanistan, Nepal and Srilanka. **Rebacca Shirley Paul** the student of Stella Maris College from Social Work Department represented India's youth delegates. We had a video session on "child rights" in evening in that I filmed "Good Nutrition" which talks about the basic needs for the for the children to be acquired.

On September we were welcomed warmly by the speaker of the parliament. And we meet the dignitaries from UNICEF and the other countries parliamentarians who presenting convention of child rights and how they are being worked in their countries. We had a photo session with speaker of the parliament Srilanka, Mr. Karujeya Surya, and also with the parliamentarians of other 7 countries and we had two parliamentarians from our country, Assam and Bihar. We got the opportunity to convey our works and our achievement with the all the parliamentarians as a youth advocate and delegates. It's a great opportunity that the youth delegates visited the residence of president of the Srilanka and had small get together with president. We have been appreciated by the president for the work towards children. Followed by we had a cultural performances in president Bungalow also we got a chance to discuss on youth pledge during dinner and took pictures with all the dignitaries. At the same day at 11.00pm we all youth delegates started to prepare our youth pledge which has been made by all other 8 countries.

On 3rd September 2019 we had the paper presenting session regarding policies towards children and women. We (youth delegates) presented initiative taken for women and children policies along with MP's of India. At the end as youth

delegates we presented our youth pledge in the dais which was been appreciated by the president of Srilanka and they made it as the youth pledge of Srilanka.

Followed by the youth pledge after a Huge fight of struggle we as youth delegates convinced all the parliamentarians of other countries in making marriage legal to both boys and girls at 18 years and above in all 8 countries, After giving valid points and interactions we made the parliamentarians including the president of Srilanka to accept and sign the declaration stating "It was principally agreed as a region, that the age of marriage for any individual should be minimum of 18 years and that the general law of the country is supreme."

We ended the conference with a huge vote of thanks followed by a small snack time and screened the filming which was made on the 1st of September. And had a small final get-together for now with the parliamentarians and departed for dinner. Had such good learning and interaction exposure from this conference made me to think in greater perspectives and got contact internationally throughout and across countries.

Learning

- Experience in interacting with youth delegates of other countries on issues of child rights and also varied exposure to cultural, social and political frameworks.
- Opportunities to interact with representatives, leaders such as ministers and the honourable president of Srilanka. Skill building with regard to communication, negotiation and documentation.
- Felt honoured and privileged to create "Youth Pledge" along with youth advocates from other countries. Researched on several child rights

issues and various measures taken by government and other stakeholders. Exposure to the gap in the implementation of child rights policies and therefore able to highlighted the need.

As part of the youth delegates group understood the process of policy formulation and acceptance of the policy at the highest level

FIGURING OUT THE POSSIBILITIES ON WHAT CAN BE DONE TO THE WALL

Media round table discussion on CRC@30 at Chennai on 26 September 2019

Media round table discussion for journalists of various media platforms from Chennai on **CONVENTION ON THE RIGHTS OF THE CHILD (CRC@30)** was on 26 September 2019 at Chennai. Initially the program started with registration where journalists took part of the discussion.

Mr. A. Devaneyan,
Director of Thozhamai
presented the welcome
address where he
started off with
cherishing the 30 years
of CRC and its growth all
over the world. He
initiated the discussion
by explaining various
approaches like child



centric approach, system approach through which we can handle and opt for children safety and protection. Mr. Devaneyan also spoke on the role of journalists with child rights in cooperation of UNCRC by explaining pocso act, juvenile justice act and national policy on children acts that work for child rights. He also discussed basic core principles to be followed while reporting on a child according to UNCRC they are,

- One should call for children first and for their safety.
- The content produced or the information of the child should be out of discrimination at all aspects.
- The news or the information published should be best interest of the child or of their parents or guardians.
- Aftermath the publishing of news, the news should not be an obstacle for the child's development or survival.
- The information or news should not be harmful to the child when heard and encountered.
- The dignity and rights of the child are to be respected at all circumstances.

Following the welcome address Prof. Andrew Sesuraj from Loyola College, Chennai presented on the establishment of CRC and the successful service of CRC@30 where the convention was adopted thirty years



ago by the UN Assembly on 20 November 1989. The convention on the rights of the child protects the rights of all children, everywhere, to be free from discrimination, violence and neglect. CRC says that children have human rights and they should be empowered to claim them which was recognized by the convention thirty years ago and entitled to non-negotiable rights. With this explanation Prof. Andrew joined with Mr. Sugata Roy, Communication Specialist of UNICEF on presenting the progress of 30 years of CRC.

The discussion exemplified with filling a questionnaire by the gathering to understand their knowledge about CRC and expectations of the group on the discussion has been analyzed where mentioned expectations to learn are, the development or progress of CRC, differences in media reporting, the way of reporting, the do's and do not's in reporting, cyber monitoring, confidentiality maintanence and expanding the ambit of CRC.

Mr. Sugata Roy presented on the progress of 30 years of child rights convention explaining right from the importance and child rights till the progress of child rights in India. He explaining the most important 3 p's which describe and enclose child rights which are protection, provision and participation. He also disclosed the principles and rooting rights of children according to CRC which has been discussed earlier by Mr. Devaneyan.

Mr. Sugata Roy then discussed about how media can effectively handle news based on children and their issues without getting affected their rights like providing reliable information ased



on article 17. Three main suggestions were provided on handling news about children which are using appropriate and harmless images of the child which doesn't affect the child's future, encouraging the child to participate if they can which will be more conventional and acceptable and portraying the information safe which can protect the children from harmful influence and doesn't affect their life or development.

Progress of CRC in India also been discussed by Mr. Sugata Roy where some of the mentioned upgrades are in the past 30 years:

- Separate ministry has been developed for women and children.
- Commission for protection of child rights has been formed in the year 2005.
- In the year 2013 national policy for children came into action and in the year 2000 juvenile justice act has came into practice.
- According to statistics there is decrease of maternal mortality and infant mortality in the past 3 years.
- There is also a decrease in children deaths due to malnutrition.
- There is a decrease in child marriage from 36% to 16.3%, child laboring from 5.76 lakh to 1.5 lakh.
- The one thing increased in recent years is child abuse which has been increased by 82% the only sad thing and need to e focused.

The session continued with case studies discussion by Mr.
Mani one of the senior journalists where he reported various children news covered in the recent days and had a detailed analysis on the pros and cons for the child with the publication of that



news coverage. He then had an open discussion with the journalists where limitations and parameters of handling news have been discussed. The gathered journalists reported their challenges in maintaining child rights at news point where all the queries ended up with one answer "best interest of the child".

The discussion has been preceded with interaction on upcoming threats which will make children suffer and make lose their lives some of them are disasters like flooding, climate changes and scarcity, migration and digital media which can affect the children in many aspects and the discussion came to an end with summarizing and remarking on the whole.

The journalist round table discussion has been successfully carried on where the program resulted with positive reflections.

Stella Maris College – UNICEF ON CAMPUS club members had Off- Campus Visit to International Justice Mission on 18 October 2019 for UOC club members.

The Unicef on campus (UOC) club of Stella Maris College, Chennai had organized their first off campus event of this

year 2019-2020 to the international justice Mission, which works to end the bonded labor system. This event focused on bringing awareness about bonded labor among the



youth Advocates of Stella Maris College. The event took place on 18 October, 2019 Friday from 10.00am to 12.00nn at the international Justice Mission, 67/28, Amar sindur Towers, Pantheon Towers Egmore, Chennai – 600008. The Orientations were given by Mr. Ruban, Lead - Law Enforcement Development.

Before the orientation, the student of Stella Maris College was told to introduce themselves.

There were 11 students along with Mrs. Arul Lenni, Campus Coordinator, UOC. In the first session Mr. Ruban oriented about human trafficking and the problem faced by the victims of it. He



shared one of his experiences where he rescued children who were working in a hazardous place. It was noticeable that, one of the rescued boy said that he will come back to Chennai but as an officer and help the bonded labor to get out of this work and to live with dignity.

The second session was conducted by Roseann Rajan who is the lead of Legal Training and Development and also a prominent lawyer of the town. Her session was very interactive and

made the youth advocates aware of how the system of bonded labor work, how poor people, children, women and elderly are being trapped into this racket. She also shared many of her experiences where they rescued the bonded laborers. She also taught us about the Article 23 which prohibits the practice of debt bondage and other forms of slavery both modern and ancient. She also taught us about the right and freedom of bonded laborers. The whole session was very interactive and fun filled one but with a serious cause.

Followed by the orientation

At the end a documentary was

played titled "The Rice Mill Story" it is an award winning movie, movie show cased the physical and mental abuses faced by the victims the way the employer fools the employees, and though the employee works hard, they are not given the wages at time and the amount is very low.

The event gave immense knowledge to the advocates and inspired them a lot to work for the under-privileged people, voice-less people and the ones who are not aware that their rights are being oppressed. This event also gave exposure to the budding advocates, the confidence to help and reform the society. The vote of thanks was delivered by Davina of I BSW student who delivered the speech and thanked the trainers who were given the orientation. She also expressed her gratitude to Dr.Sr.Lourthu Mary, patron of UOC and Ms.Vijayalakshmi, faculty coordinator of UOC for providing this wonderful opportunity, to learn about Bonded Labor. The youth advocates felt empowered after the session.

Amplifying Voice of Adolescents and Young people for Child rights for Youth Advocate for Children (YA4C) at Society of Peace, Yercaud, Salem on 11-13 November 2019

In order to amplify voice and build capacities of Youth Advocates from selected UOC members from Stella Maris College was organized at Yercaud , Salem district on 11-13 November 2019

This programme is to help the Youth Advocates to find the strategies to amplify their voices for the rights of Children and to improve their skills / knowledge on 'Child Rights' to a select group of Youth Advocates from UNICEF on Campus Club, Stella Maris College.

PLAN OF ACTION

- About 36 students from the Department of Social work were selected by Ms. Tryphena Persis
 President of UOC and Ms. Lakshana Roopavathy Vice President of UOC with the Support of
 Ms. Vijayalakshmi, faculty coordinator of UOC to attend a training camp on child rights held
 in Yercaud from the 10th to 14th of November, 2019
- The students were accompanied by Ms Arul Lenni (UNICEF coordinator-SMC), Dr.Sr.Lourthu Mary (HOD,Social Work PG), Mr. Devaneyan (Director,Thozhamai), Mr Balaji (Thozhamai).
- The core idea of the camp was to transform UOC members into youth advocates with a social and moral responsibility towards children.
- The process of this journey was to be made using both intellectual and artistic tools such as discussions on CRC and street theatre sessions.
- The transition of the students was motivated by the core members of the UOC Club.
- Constructive criticism was taken and feedback was acknowledged.
- The student bonds were strengthened and cooperation was to be seen.



11 November 2019 - Objectives of the day

- 1. To Explore Yercaud as a Eco-friendly destination.
- 2. To get an in-depth understanding of CRC and its strong points and short falls.
- 3. To understand and discuss where CRC must be focused on in the near future.

Day wise Activities:

Sight Seeing:

As part of exploring Yercaud, the students visited the Pagoda Point and the Botanical Gardens. The view was amazing and that led us to get a few candid shots along the way. The fog and the cold weather were pleasant to experience. After walking along the nature we were refreshed and had some time to relax thereafter in our dormitories.



Mr Devaneyan and Sr Lourthu Mary's Address:

The welcome address and introduction to the workshop on child rights explained the value of positive change and the need for a voice for the voiceless children. The target group on focusing on children was decided due to them being the most vulnerable, naive and pitiable in a society which is changing. The need to assimilate, engage and personalize messages and services to support the children are seen as a need for



development and improving the nation as a whole.

Mr Sugata Roy's Address:

Mr Sugata Roy spoke about the CRC being the 'Convention on the rights of the children' delivering primarily into the four basic rights such as survival, protection, participation and development. The question to why child rights are viewed specially was answered by him. The children are individuals who are dependent on caregivers from birth till adolescence. They are the most vulnerable



community to both abuse and exploitation. The inaction of the government affects children in terms of lack of psycho social support. The participation of children is not regarded and has taken a back seat in many decision making processes including when the decisions are made for the children. They need to allow the children to participate, choose and be free are seen as an integral part of the CRC and even the SDG's since the time it was a ratified document in 1989.

Legal Perspective:

Multiple attempts were made prior to the initiation of CRC for effective, formal, working documents to be made for the children and safeguarding their rights.

The 1924's 'Geneva Declaration on the rights of children' focused on child protection and the League of Nations after WW1. The Indian signatory who signed this document was none other than MK Gandhi.

In 1959, the 'Declaration on the Rights of the Child' was adopted by the UN.

On 20th November,1989 the 'CRC' unlike the GRDC or the DRC of 1992 wasn't a declaration but a convention that was ratified and signed by about 150 countries.

The GRDC focused on only protection. The DRC focused only on provision. The CRC focused on a three pronged approach of working with protection, provision and participation of the children. The CRC understood the importance of the family. And as CRC was a convention it held mandatory terms and enforced implementation of a certain agenda.

It is noted that despite heavily funding UNICEF and other child protection mechanisms the CRC was not signed by the United States of America.

Structure of CRC and the Child Rights Lens:

The CRC has 54 articles, 42 rights and 12 responsibilities of the state. It's principles such as non discrimination, keeping the best interest of the child and considers the views of the child.

The CRC document mentions that there are two groups of people involved 1) The Right Holders - those who are the caregivers, parents, guardians and the child. 2) The The Duty Bearers - those who are in a position to better things such as the primary level being state and secondary level being parents etc. It is of importance to understand that children have rights and they don't need pity and sympathy to be attached to regular opportunities that they can attain.

The child rights lens has 3 main areas of consideration such as 1.Image of the child, 2.Children's participation in the media and 3.Protection from harmful influences in media.

Progress of CRC in India:


The JJ ACT, Child Marriage Act, PNT Act and others are seen as crucial steps taken by the government towards child rights.

The NCPCR, State Commission of rights are quasi judicial bodies which help promulgate bettered ordinances and responses towards supporting children and their development.

The changes in rates of maternal mortality rate, infant mortality rate, malnutrition rate and the budget for education is recognized. The numbers have been improving but actual growth is still a question mark.

It is also noted that 1 child gets abused every 2 days in 2016. and the rate of rape has increased from 82% in 2015 to 2016. These statistics pose a very fearful and detrimental picture of the situation as is in India.

The Challenges that are beyond CRC are:



Outcomes from the session:

The session was very reflective of the current day issues faced by children. The fear of tackling social media is huge part that has to be seen in newer considerations of CRC. The one thing that the CRC looks forwards to in the next generation is hope to overcome. This session instilled knowledge of the CRC and its intricate details towards rights, justice and the future. As the current generation, it is becoming more and more important to safeguard ourselves from the digital footprint and take steps towards information and its misuse.

12 November 2019 - Objectives of the day

- 1. To appreciate street theatre as an active skill and tool
- 2. To learn and interact in forming a play on child marriage
- 3. To learn and present a play on child abuse using the varied case histories



Mr.A.Devaneyan - Recap of Session:

In this session, there was a quick recap on child rights and its necessities. Sir also explained the need for instantaneous action in terms of child abuse and child marriage. It is essential for the message of such ill happenings to be spread across by local art forms to stress on justice, need for equality and governmental action. Sir spoke about the need to learn to write petitions and letters to officials from positions of power. This session was empowering and knowledgeable.

Dr Kaleeswaran - Amplifying Voices: Street Theatre Training

The street theatre training began with the understanding of theaters to be either a round or rectangular theatre. Following that, the students were given a set of activities to exercise their voice, and experiment with movement. Posing as a statue was also one among the tasks given. The students enacted various scenes to represent a landmine affected



area, and furthered it by doing scenes to replicate a story on child marriage. The story actively engaged the factors of helpline numbers, support members and what is child marriage and who are the perpetrators who can be arrested for getting a child married. This was interwoven by the comic stance taken by the clown to tell the story of a young girl who was the victim. This story was moving and had us deeply involved and mixed from our regular working groups. The activities enforced group decision making and cooperation.

In the second half of the street theatre session, we were educated about different cases of child abuse. From these instances we learned to perform a play crafted by him. This play was short and thoughtful about the victim's feelings and concluded with a new age solution of having a child safety committee in every apartment to safeguard the interests of the child.

Outcomes from the session:

This session helped us better ourselves in terms of stage presence and put together a play. The process of forming the street theatre led us to work better with one another, gave us a chance of delivering the message in our own way and held a key criterion of up-keeping the originality and individuality of the character whom we played.

13 November 2019 - Objectives of the day:

- **1.** Transforming from youth to youth advocates
- 2. To look at the post questionnaire
- 3. To assimilate the experience of the overall trip
- 4. To enjoy sight seeing

Plan of Action and way forward:

The plan of action was directed towards 3 things namely:

- ♦The street theatre performance
- ♦ Sustainability of UNICEF Club
- ♦ Ways to channelize online, offline, short term and long term goals

Ideas of the student groups included club elections, certificate programs,



YouTube or blogging channel, comic books, academic papers, marathons, panel discussions, open mics, corporate social responsibility engagements, specialist keynote addresses, paper articles, signature campaigns, school quiz contests, documentaries, school engagements, leadership training sessions, skill development apart from information pamphlets and brochures.

Pledge and certificate distribution:

A pledge of helping to preserve child rights and become the voice of the voiceless was taken by each student. The common responses included the fact that the session was informative and knowledgeable. The certificates were distributed along with a tea cup and a UNICEF T-shirt for the participants.



Feedback:

The following feedback was given by the youth advocates

- This is one of the best camps, I have ever been to, I had a lot to learn about child rights and street theatre was really good as a person who can't act it was really new experience. The accommodation for this camp is one of the best things. I had so much fun into this camp. It was a really informative and memorable camp
- Being a social worker never had a lot of exposure about child rights. This session was helpful in knowing a lot about CRC and its challenges. Trust issues being an issue were more than

our imagination. Realized that we have to work on more for better society. The street theatre session gave us more insight about expression something other than in form of words.

This three day camp for YOUTH ADVOCACY AND CHILD RIGHTS was really very helpful, it gave us the confidence and courage to question those who violate or abuse the child rights and children. Sugata Sir's session and the street theatre practice taught us many



things. The atmosphere of the place is really amazing and the camp has empowered each one of us. It has made us think' feel how children feel when their rights are violated.

- I personally liked the session it was very engaging especially in my semester holidays. I hope that I've utilized well. Camp is the platform where we can learn theories in practice in a fulfilled way where we get involved with others and work towards a common goal.
- We keep raising our voices in hopes that maybe we can be as loud as all the children who screamed for help. And may be when we scream together, we'll turn heads
- The overall camp was really awesome. I had studied a lot from this UOC camp. It had taught
 me more about child rights and the upcoming challenges in future. It had been really an
 amazing experience to be a part of this Yercaud camp.

Suggestions:

- It would be good if there were more group work sessions and discussion of case studies
 pertaining to children so that we get a broader perspective of the reality and the society.
 Waiting for more such camps to enhance our skills as well and to collaborate with others.
- It was such an amazing experience but was need to have more of interactive sessions, games, group works, group discussions, screening, movies and documentation. But there is no longer break.
- The classes could have been interactive with more breaks and language barrier was also an issue.
- I would suggest the organizers to include more play method of activities than lectures.
- The period of the camp may also be extended.

- Need to discuss about topics like bullying in schools. We should work for all children times
 we only discuss about student who are underprivileged but there is a need to discuss about
 students of privileged society and the challenges faced by them.
- I would really suggest in the presentation part of Mr.Sugata Roy sir, to be have more details
 with Schemes, Policies, Articles and the work of his in the UNICEF and to conduct activities
 eye brake session etc., to enhance the session.

Photo Session:

The photo session was a fun filled session. This session let us relax and pose for the cameras. The pictures mirrored our learning and enjoyment by far. This session was important as it led the documentation to be strong and keep up the records. The CRC boards and UNICEF T-shirt truly marked our journey's highest points.





Outcomes from the session:

The outcome of the final journey marked our transition from UNICEF on Campus Club members to youth advocates with a potential responsibility towards the society and children as a community. The learning was consistent and was led by experience. The session was well planned and emphasized on students ideas towards a sustainable future for the club and the goals on a larger picture.

Overall outcome of the UOC Youth Advocates:

Using pre and post camp assessment questionnaire on child rights assessed the level of the knowledge on child rights. The total average of Pre camp assessment is 60% and post camp assessment is 80%. So comparing the outcome of the both assessments it was noted that 20% of knowledge was improved by the youth advocates due to the camp.

Sight Seeing:

We visited a park and followed that by a boating experience in Yercaud. Many also bought Yercaud's homemade chocolates to commemorate the experience. We travelled the hairpin bends and through Salem in a bus journey which was high on music and entertainment.





In Commemoration of World Children's day on 20 November 2019 Stella Maris College – UNICEF ON CAMPUS – Youth Advocate for Children performed Street Theatre on Child rights at the following places

Don Bosco Beattitudes, Vysarpadi on 20 November 2019

On 20 November 2019, the UNICEF on Campus team, Stella Maris College, organized an awareness program for the students at the Don Bosco Beatitudes school, Vyasarpadi. The program was conducted in order to celebrate World Children's Day and CRC 30 years since the Convention of the Rights of the Child was implemented.



Students of Middle, High and Higher

Secondary sections of the school were asked to participate in the program. The team first spoke to the Father Thomas, Principal of the school, followed by which the program commenced. A brief overview about the team and the reasons behind celebrating the above mentioned events were given to the students by the Principal and the faculty of the school, after which the team performed the street play

The UOC Team then performed a Street theatre on the four definite rights that every child has – Education, Development, Protection and Participation. The street theatre revolved around the violations of each of these rights, which were then followed by the necessary steps needed to be taken in order to solve the violation. The team hoped to convey



mandatory information that each child should know through the street theatre performance itself.

Some of the messages the team spoke about during their stage are as follows:

- Information on Childline Number 1098.
- Necessity of 'Shout Run Tell' when abused.
- Emphasis of Marital age for a Male and a Female.
- Importance of being non gender biased.

The team then posed different questions to the student body in order to understand their level of learning from the street theatre and the students were quick to respond to them all. After the program ended, the team met up again with Principal Father and post refreshments, wrapped up the event.



Learning

This particular event involved a large group of young minds which is open to grasping any new information. It was a task for the team to stay focused on giving the correct, relevant and important information which can have a major impact on the students. Also the skill of keeping over 700 students entertained and at the same time getting them to concentrate on the theatre was something the team learnt from the event. Overall, the goal – which was to let children know how important they are to the future and how each of them possess rights – was achieved.

Villivakam Railway Station as part of inaugurating the Child Line helpdesk by Myrtle, Social Welfare Trust, Perambur.

Inauguration of child line services in the Villivakkam railway station and also the part of celebration of World 20th Children's Day November 2019 was organized by Myrtle, a social welfare trust. which working for children and deprived classes, and also with the support of the



Villivakkam Railway Police Department.

Child Abuse in Chennai is one of the biggest social Stigmas attached to the society. Child abuse can take place in homes (apartments), schools, Orphanages, residential care facilities, on the street and in places of detention. The UNICEF ON CAMPUS club of Stella Maris College works to sensitise people by creating awareness on issues, abuses and violence faced by children. The Youth Advocates sensitise people through social media and other conventional



mediums like the street theatre.

Stella Maris College – UNICEF ON CAMPUS club members had off-Campus Visit to Aid India, Chennai on 7 December 2019.

The Unicef On Campus (UOC) club of Stella Maris college, Chennai, had Off-Campus event for the members of the club on 7 December,2019 Saturday at Aid India, No:45, Pycrofts Road, First Street, Express Estate, Triplicane, Royapettah, Chennai –04.

The main aim of the visit was to bring awareness about the hardships faced by the children and how the organization helps them to cope up with it to the members of the UOC club. The members were divided into two batches for the visit accompanied



by Ms. Arul Lenni, Coordinator of the UOC club. In the morning batch 28 students from Shift I had visited the organization from 9.00am to 10.30am; the afternoon batch 25 students from Shift II had visited the organization from 2.00pm to 3.30pm. The morning session was addressed by Ms.Gowri, Aid India and the afternoon session was addressed by Ms.Revathi, Aid India. In the orientation session they shared lot of information activities they do to promote Children's education, well being etc.

The organization's main focus is children and their well being, they strive to help children enjoy their rights, so that the vulnerable children get their basic needs. The Motto of the organization is "REACH THE UNREACH", they travel to different rural areas to teach children, bring awareness about sanitation, safe and unsafe touch etc.



They are assigned with 4 major projects:

WALK AND TALK:

The aim of the project is to make children, learn English, so that they can converse in English confidentially as well as fluently. For the practice of this project they visit the rural areas

along with the volunteers teach children and English. Sometimes they conduct workshops on soft skills for the graduates of the village so, that they can help the children on daily basis, and through this



workshop the graduates themselves get empowered. They have been to travel Tirutani to teach the children. They also conduct many activities for the children to make the learning easier.

TOY JOY:

The organization came up with an innovative idea of collecting toys from corporate, colleges and schools to distribute it among one lakh children who have no toys and never experienced the joy of owning a toy. The quote for this project is "One Lakh Toys for One Lakh Children"



HOMES:

People who had lost their houses during the floods and Gaja Cyclone are homeless; therefore, the organization helps them by building new houses, so that they can lead a safety life.

WE: Women Empowerment:

They conduct workshops on topics like women empowerment, Physical abuse, Work place harassment etc, so that they can report any such abuses to the police because women in rural areas are not aware with such laws.

The organization also conducts many workshops at Prisons and Juvenile Homes so, that the mental health of the prisoners could be improved and they can be motivated to lead a good life after their punishment time gets over, after they come out of prison.

They also conduct workshops at schools, colleges and corporate on how the organization works so, that the corporate could help them. The funds for the organization are provided by the corporate. Overall the session was interactive and the members expressed their views to help the organization to expand the tie up's also they have by involving the student's participation.

The student responded by saying that they can perform street theaters; they also said the organization could put-up stalls at various colleges and schools. Ms. Revathi also explained the procedure of volunteering, interested students can enroll them with the organization, and help them to document the activities or travel to villages and teach children English etc.

The students got very motivated after the orientation to help children in any possible way they could. They also appreciated the work the organization was doing as they are very dedicated to serve the children so, that the rural and tribal children get their rights. After the orientation got over all the students thanked the Ms. Gowri and Ms. Revathi for sharing their works with the students. Later the members visited the library at the organization, where they had collected a lot of books to distribute to those children. And segregate the toys for distributing the children and separated the damaged toys from the collection of toys.

All the students enjoyed the ambience of the organization and were determined to help children in any possible way.

Capacity Building for Child Rights and Child Protection for Ending all form of Violence Against Children for UOC members of Stella Maris College, Chennai on 17 December 2019

The training programme was started with prayer by the team of II BSW students and Ms. Pravara, II BSW students as well as the youth advocates welcomed the dignitaries and the audience who gathered. Ms. Shruthi Mukunth, UOC member introduces Mr.Devaneyan, Director of Thozhamai and handed over the session to him.

Mr Devaneyan's Address:

Children learn by seeing parents and role model after them. Practice of violence against children and the use of abusive language and hand rising mostly start from home.

Children need to be grown with their best interest kept in mind. They are vulnerable, powerless and naive therefore they need more support and help legally and constitutionally. They are also considered



It is to note that according to mandates and other legal documents it has been decided that children need a rights based approach to govern them rather than a mercy based approach which looks at them in a degrading manner.

According to the UNCRC it was decided that children have the 4 rights of life, protection, development and participation. They need protection from the 4 types of abuses such as physical, sexual, emotional abuse and neglect.



The various case studies of Padapai's compound wall fight, world war 2's child soldiers, Bhopal's Union Carbide issue, UP's oxygen loss deaths, Kumbakonam 's fire accident, aynavaram Rape case were all looked into from the child rights frame work. It was seen that gender sensitization, boy child education are all the needs of the day and have to be focused on.

The next session was taken by Mr. Thenpandian, Lawyer working with the POCSO act who was introduced by Mr. Devaneyan.

Mr Thenpandian's address

Mr Thenpandian spoke about POCSO as against most child protective laws. He spoke about the People's Forum of Human Rights.

Children are vulnerable, innocent and dependent and they are a big concentration of the people in India. 45% of the children are susceptible to wrongful treatment or abuse due to the lack of awareness.

The approach of duty bearers and right holders was also thoroughly discussed.

With regards to POCSO, he mentioned that off every 100 children 53 claim to experience sexual abuse as a child and this would need a lot of attention and protection.



What's coming up?



Madurai MP Su. Venkatesan on Wednesday said crimes against women and children had risen by 250%, according to data provided by the National Crime Records Bureau (NCRB).

Speaking at Negizchi 2020, an event organised by Lady Doak College on its premises in collaboration with UNICEF focussing on the need to end violence against women and chil dren, Mr. Venkatesan said it was essential for men to stop being primitive to stop perpetuating crimes.

Until then, the notion of development will be non-existent," he felt.

The district administration and authorities from various departments, including the Child Committee and the District Child Protection Unit, must make efforts to ensure that any and all child marriages

were stopped in Madurai. "If the Collector of a small

district like Perambalur can stop 600 child marriages in a year, we must stop at least 10 times the number of mar riages in our district," he

The MP said that there was a need to keep a close watch on the relationship between the number of drop-outs and the number of juveniles convicted for murder. To ensure that students did not go astray, education routes must be strengthened.

To live, they need to fight

D. Rajalakshmi, a 15-year-old student from Maniyakaranpatti, a village located 15 km from Dindigul, says she vividly recollects the time when her close friend was about to be married off to a much older man. "My friend and I would always roam around together both school and outside of it. Her parents one day told her that she would be married off and she had no choice. She too agreed. The incident left me shocked," she says. Rajalakshmi and her

friend are both members of 'Childvoice,' a non-govern-mental organisation work-ing for protecting children's rights, and had attended ses-sions on child abuse, marriage and labour together in 2012. When her friend submitted to the institution of child marriage, Ms. Rajalakshmi says she took mat-ters into her own hands Although she tried talking her friend out of it, her parents were unapproachable, she says. "That is when I called the Childline service and they intervened," says. Like Rajalakshmi, three others - M. Santosh Kumar, M. Vishali and A. Jeyapra-



Dindigul. Their efforts have earned them praise from UN-ICEF in November 2019 and most recently at Lady Doak College. Rajalakshmi and her fellow activist 17-year-old M. Santosh Kumar from Sangalpatti say the biggest pro blem they currently face is against child labour.

"Parents somehow think that their child and the family will have a better life if the work. The child too is enamoured by the opportunity to leave the village and see the world. We have a respon sibility to tell the ones around us about the terrible working hours and abuse there. So many boys have escaped from firecracker-mak units, cloth manufacturers with nothing. Our Dindigul boys are often sent to the

kash. "I was about to be sent to Delhi," he says. According to Jeyaprakash who was supposed to work as a 'shop boy, the prospect of seeing a new city was exciting but only after his friend spoke to him did he realise the dangers. "I received counselling from my peers and my pa-rents had a discussion with social workers. I am now back in school," he says.

Thirteen-year-old Vishali who has begun the conversation regarding alcoholic and abusive parents in her village Viralipatti, says she and her friends aim to alleviate the underprivileged from regressive ideas perpetrated over generations. "We help our friends survive and spread the message of reaching out to Childline and the police because many of us we must fight," she says.

- On June 5th 2019 Shout for Freedom organized a meeting of CSOs to discuss raising up volunteer foot soldiers from the grassroots levels to create awareness, identify and report cases on bonded labour and human trafficking to the relevant government authorities or the coalition members. The bonded labour system and human trafficking are not so visible forms of labour exploitation. Legal action is taken only when individual cases get exposed through individuals or organizations complaining against such forms. There is no mechanism whatsoever to proactively identify such cases and take further action. Thus, it is necessary to create a set of defenders in these prevalent areas which are known for such forms of human rights violation. This will be crucial to address the hidden and invisible forms of unfair and illegal forms of labour.
- On June 12th A press meet was organized by Unorganized Worker's Federation (Thozhilalar koodam) in view of #WorldDayAgainstChildLabour to raise the voice of the affected children for justice & advocate right to education for all children. Our convener, Mr. Devaneyan represented the coalition and spoke highlighting the issue of #ChildBondedLabour. Sathiyam TV airing a #live interview on the occasion of #WorldDayAgainstChildLabour featuring our convenor Mr. Devaneyan and Mr. Kuralamuthan, IJM.It also featured #BondedLabour survivor and Released Bonded Labour Association (RBLA) leader, Sakunthala.
- On 21st June 6 bonded labourers, including 4 minors, were rescued from a Water Treatment Plant in Chennai with the help of Thozhamai NGO chennai. On 26th June Government proactively sealed two water treatment plants in Chennai after rescuing 6 boys from the plant in Chennai. All the 6, including 4 minors, migrants from Odisha, were made to work as bonded labourers.
